RECOMMENDED MOTION (continued):

3. If the owner or whoever has possession of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.

4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.

5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

1. An inspection was made on the subject property by Code Enforcement Officer Rusty Hannah on April 24, 2014. The inspection revealed excessive outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinances Nos. 348 and 541. The items included but were not limited to: metal, plastic, wood, furniture, household items, clothes, blankets and personal items, of about 1,200 square feet.

2. There have been approximately nine (9) subsequent follow up inspections, with the last inspection occurring on July 23, 2015. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.

3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance, and potential impact on real estate values.

11 I, Rusty Hannah, declare that the facts set forth below are personally known to me except to
12 the extent that certain information is based on information and belief which I believe to be true, and if
13 called as a witness, I could and would competently testify thereof under oath:

14 1. I am currently employed by the Riverside County Code Enforcement Department as a
15 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
16 property for violations and enforcement of the provisions of Riverside County Ordinances.

17 2. On April 24, 2014, I conducted an inspection of the real property described as 16160
18 Avenida Rambla, Desert Hot Springs, Riverside County, California and further described as Assessor's
19 Parcel Number 657-181-034 (hereinafter described as "THE PROPERTY"). A true and correct copy of a
20 Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and
21 incorporated herein by reference as Exhibit "A."

22 3. A review of County records and documents disclosed that THE PROPERTY is owned by
23 Henry B. Burrows (hereinafter referred to as "OWNER"). A certified copy of the County Equalized
24 Assessment Roll for 2015-2016 tax year and a copy of the report generated from the County Geographic
25 Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." The
26 property is an improved parcel approximately 0.16 acres in size and is located within the W-2 (Controlled
27 Development Areas) zone classification. The parcel size is less than the minimum size requirements
28 and therefore does not allow any amount of outside storage on THE PROPERTY. Accumulated rubbish
in not permitted on any property within the County of Riverside.

1 4. Based on the Lot Book Report from RZ Title Service dated March 19, 2015 and updated
2 on August 10, 2015, there appears to be no other parties that may hold an interest in THE PROPERTY.
3 True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by
4 reference as Exhibit "C."

5 5. On April 24, 2014, I arrived at THE PROPERTY to conduct an inspection. I observed
6 excess outside storage and accumulated rubbish on THE PROPERTY. The outside storage of materials
7 and accumulated rubbish consisted of, but was not limited to: metal, plastic, wood, furniture, household
8 items, clothes, blankets and personal items of about 1,200 square feet. This condition causes THE
9 PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County
10 Ordinance ("RCO") Nos. 348 and 541.

11 6. On April 24, 2014 and June 4, 2015, Notices of Violation were posted on THE
12 PROPERTY.

13 7. On April 25, 2014, June 24, 2014, December 18, 2014, April 17, 2015, and June 23, 2015,
14 Notices of Violation were mailed to OWNER by first class mail.

15 8. A site plan and photographs depicting the conditions of THE PROPERTY are attached
16 hereto and incorporated herein by reference as Exhibit "D."

17 9. True and correct copies of each Notice issued in this matter and other supporting
18 documentation are attached hereto and incorporated herein by reference as Exhibit "E."

19 10. There have been approximately nine (9) subsequent follow up inspections, with the last
20 inspection being July 23, 2015. Each inspection revealed the accumulated rubbish and excess outside
21 storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.

22 11. Based upon my experience, knowledge and visual observations, it is my determination
23 that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the
24 general public.

25 12. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO
26 Nos. 348 and 541.

1 13. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the
2 County Recorder, County of Riverside, State of California, on September 18, 2014, as Instrument
3 Number 2014-0354114. A true and correct copy of which is attached hereto and incorporated herein by
4 reference as Exhibit "F."

5 14. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing
6 notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER by
7 first class mail and was posted on THE PROPERTY. True and correct copies of the Notices, together
8 with the Proofs of Service, and the Affidavit of Posting of Notices are attached hereto and incorporated
9 herein by reference as Exhibit "G."

10 15. The removal of all accumulated rubbish and excess outside storage of materials currently
11 on THE PROPERTY is required to bring THE PROPERTY into compliance with RCO Nos. 348 and 541,
12 and the Health and Safety Code.

13 16. Accordingly, the following findings and conclusions are recommended:

14 (a) the excessive outside storage of materials and accumulated rubbish on THE
15 PROPERTY to be deemed and declared a public nuisance; and

16 (b) the OWNER, or whoever has possession or control of THE PROPERTY, be
17 required to remove all outside storage and accumulated rubbish on THE PROPERTY in strict
18 accordance with the provisions of RCO Nos. 348 and 541.

19 (c) that if the materials and rubbish are not removed and disposed of in strict
20 accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541,
21 within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, the
22 outside storage of materials and accumulated rubbish may be abated and disposed of by representatives
23 of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon
24 receipt of owner's consent or a Court Order when necessary under applicable law.

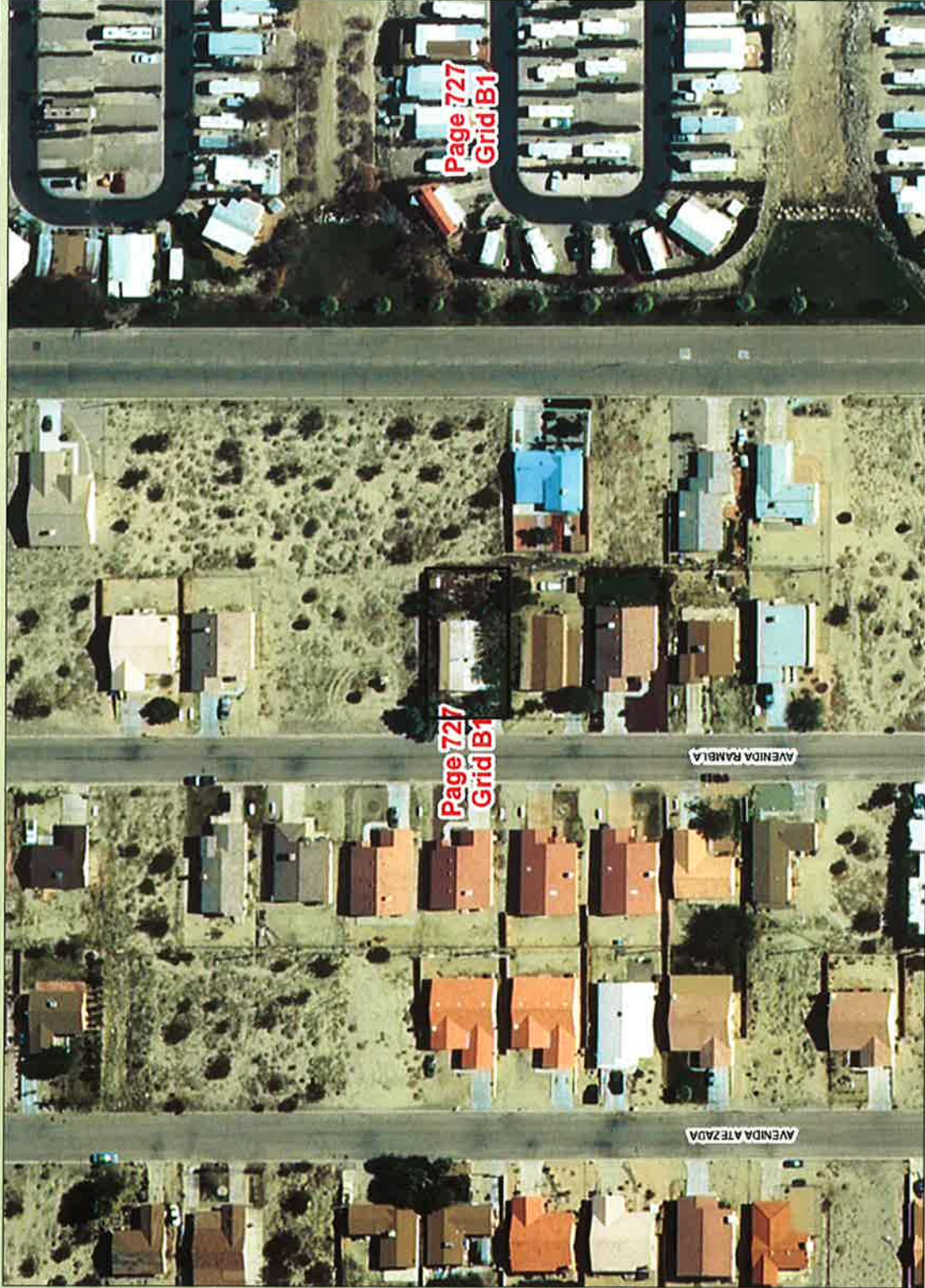
