Receive and File notice of Environmental Health fee adjustments pursuant to Ordinance 640.

**BACKGROUND:**

**Summary**

On July 14, 2014, Item 9-4, your Board approved a revision to Ordinance 640, Environmental Health Service Fees. The revised ordinance authorizes Environmental Health to adjust the fees in Ordinance 640 each year to reflect the change in the Consumer Price Index (CPI). The Ordinance also requires Environmental Health to file a report to the Board of Supervisors, no later than April 15<sup>th</sup> of each year, reporting the new fees. As required by the Ordinance Environmental Health must certify in the report that "(1) the new required fees produce sufficient revenue to support the proposed costs of providing the services in the upcoming fiscal year for which required fees are being charged and (2) the new required fees will not produce revenue that exceeds the proposed costs of providing the services in the upcoming fiscal year for which the new required fees are charged."

**BACKGROUND:**

**Summary (continued)**

Environmental Health has submitted its FY 16-17 departmental budget to the Executive Office. In preparing the budget it was necessary to adjust the Ordinance 640 fees by the CPI, which for 2015 was 2%, to offset increases in salaries and benefits and other operating costs. Environmental Health used U.S. Department of Labor Bureau of Labor Statistics report for the Los Angeles-Riverside-Orange County CPI-U area as the relevant CPI (please see Attachment A).

In accordance with the Ordinance, the Department of Environmental Health certifies that the 2% adjustment in fees will be sufficient to meet the department's FY 16-17 budget needs of the programs funded by those fees, as submitted to the Executive Office, and that the revenue produced by the adjusted fees are not in excess of what is necessary to provide services in FY 16-17. The Ordinance 640 Fee Adjustment Comparison Schedule and Fee Schedule are attached as Attachment B and C respectively.

**Impact on Residents and Businesses**

Businesses will be moderately impacted by increased fees for food facility permits, public pool permits and plan checks, body art permits, solid waste and hazardous material related activities, septic tank and water well permits.

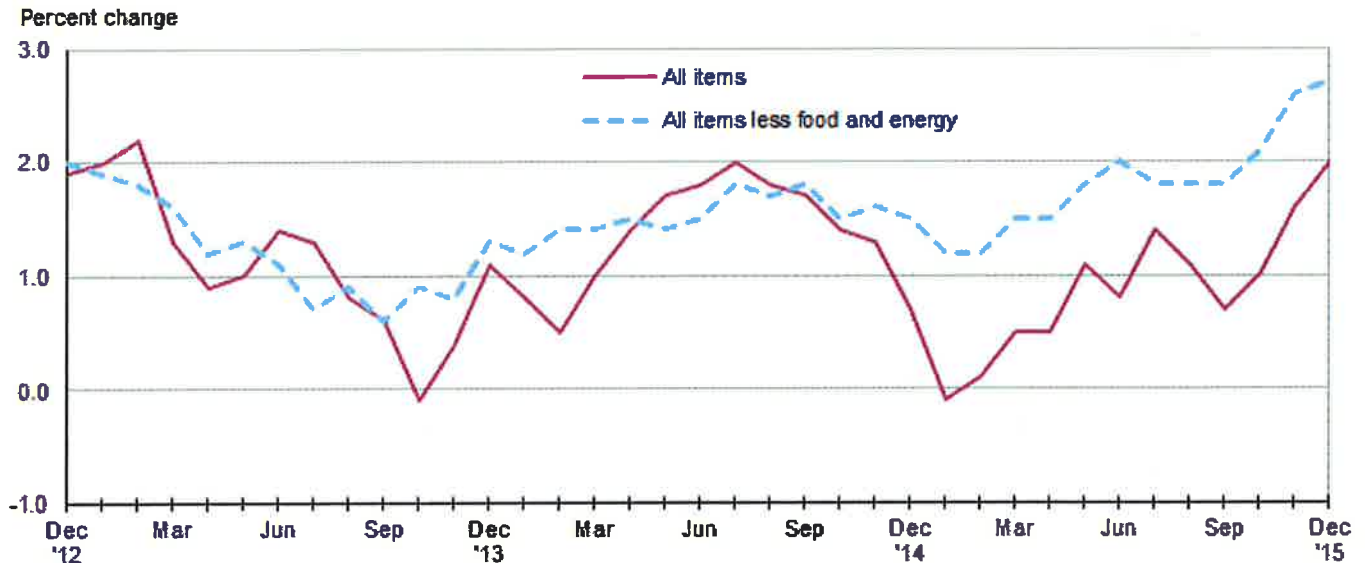
## Consumer Price Index, Los Angeles area — December 2015

Area prices were down 0.1 percent over the past month, up 2.0 percent from a year ago

Prices in the Los Angeles area, as measured by the Consumer Price Index for All Urban Consumers (CPI-U), inched down 0.1 percent in December, the U.S. Bureau of Labor Statistics reported today. (See [table A.](#)) Regional Commissioner Richard J. Holden noted that the December decrease was influenced by lower prices for food at home and apparel. (Data in this report are not seasonally adjusted. Accordingly, month-to-month changes may reflect seasonal influences.)

Over the last 12 months, the CPI-U advanced 2.0 percent. (See [chart 1](#) and [table A.](#)) Energy prices declined 3.0 percent, largely the result of a decrease in the price of electricity. The index for all items less food and energy increased 2.8 percent over the year. (See [table 1.](#))

**Food**

Food prices decreased 0.8 percent for the month of December. (See [table 1.](#)) Prices for food at home declined 1.6 percent, yet prices for food away from home inched up 0.2 percent for the same period.

Over the year, food prices rose 0.5 percent. Prices for food away from home increased 2.8 percent since a year ago, but prices for food at home decreased 1.1 percent.

**Energy**

The energy index decreased 0.4 percent over the month. The decrease was mainly due to lower prices for electricity (-1.6 percent). Prices for gasoline decreased 0.7 percent, but prices for natural gas service advanced 4.4 percent for the same period.

Energy prices declined 3.0 percent over the year, largely due to lower prices for electricity (-6.0 percent). Prices paid for natural gas service decreased 7.2 percent and prices for gasoline decreased 0.4 percent, during the past year.

**All items less food and energy**

The index for all items less food and energy was unchanged in December. Higher prices for household furnishings and operations (1.1 percent) and shelter (0.4 percent) were partially offset by lower prices for apparel (-3.7 percent) and other goods and services (-0.4 percent).

Over the year, the index for all items less food and energy increased 2.8 percent. Components contributing to the increase included medical care (4.4 percent) and recreation (4.3 percent). Partly offsetting the increases was a price decline in apparel (-0.3 percent).

**The January 2016 Consumer Price Index for the Los Angeles-Riverside-Orange County is scheduled to be released on February 19, 2016.**

### **Technical Note**

The Consumer Price Index (CPI) is a measure of the average change in prices over time in a fixed market basket of goods and services. The Bureau of Labor Statistics publishes CPIs for two population groups: (1) a CPI for All Urban Consumers (CPI-U) which covers approximately 89 percent of the total population and (2) a CPI for Urban Wage Earners and Clerical Workers (CPI-W) which covers 28 percent of the total population. The CPI-U includes, in addition to wage earners and clerical workers, groups such as professional, managerial, and technical workers, the self-employed, short-term workers, the unemployed, and retirees and others not in the labor force.

The CPI is based on prices of food, clothing, shelter, and fuels, transportation fares, charges for doctors' and dentists' services, drugs, and the other goods and services that people buy for day-to-day living. Each month, prices are collected in 87 urban areas across the country from about 6,000 housing units and approximately 24,000 retail establishments--department stores, supermarkets, hospitals, filling stations, and other types of stores and service establishments. All taxes directly associated with the purchase and use of items are included in the index.

The index measures price changes from a designated reference date (1982-84) that equals 100.0. An increase of 16.5 percent, for example, is shown as 116.5. This change can also be expressed in dollars as follows: the price of a base period "market basket" of goods and services in the CPI has risen from \$10 in 1982-84 to \$11.65. In calculating the index, price changes for the various items in each location are averaged together with weights that represent their importance in the spending of the appropriate population group. Local data are then combined to obtain a U.S. city average. Because the sample size of a local area is smaller, the local area index is subject to substantially more sampling and other measurement error than the national index. In addition, local indexes are not adjusted for seasonal influences. As a result, local area indexes show greater volatility than the national index, although their long-term trends are quite similar. **NOTE:Area indexes do not measure differences in the level of prices between cities; they only measure the average change in prices for each area since the base period.**

The Los Angeles-Riverside-Orange County, CA. metropolitan area covered in this release is comprised of Los Angeles, Orange, Riverside, San Bernardino, and Ventura Counties in the State of California.
