Summary

Departmental Concurrence

Change of Zone Case No. 7888 (CZ 7888) changes the zoning from Controlled Development Area, 10-Acre Minimum (W-2-10) to Manufacturing — Service Commercial (M-SC) on two parcels, totaling 160-acres. The public hearing for CZ 7888 was held on February 9, 2016 as Agenda Item No. 16-6. At the conclusion of public testimony, the Board of Supervisors closed the public hearing, adopted a Mitigated Negative Declaration for Environmental Assessment No. 41826 and tentatively approved CZ 7888.

Pursuant to Section 4.1 of Ordinance No. 348, the County's unincorporated area is placed in mapped zoning districts. Adoption of Ordinance No. 348.4833 will finalize the Board's tentative action on CZ 7888, formally change the property's zoning classification and amend the County's zoning map to reflect the new zoning classification.

On February 9, 2016, the Board also tentatively approved General Plan Amendment No. 997 amending the site's General Plan Foundation Component from Open Space (OS) to Community Development (CD) and amending its General Plan Land Use Designation from Rural (RUR) to Light Industrial (LI) (0.25 – 0.60 FAR).

On March 29, 2016, General Plan Amendment No. 997 received final approval with the Board's adoption of Resolution No. 2016-098 (the first cycle of General Plan Amendments for 2016).

The property is located north of Vista Chino, west of Rio Del Sol Road, and east of Varner Road as shown on the attached maps entitled "Vicinity/Policy Areas" and "Proposed Zoning."

Impact on Citizens and Businesses

The impacts of processing Change of Zone Case No. 7888 and adoption of this ordinance have been evaluated through the environmental review and public hearing process by staff, the Planning Commission and the Board of Supervisors. The opportunity for public review and comment was provided during the public hearings scheduled for this change of zone and any verbal or written testimony provided by the public was considered by the hearing body at that time. Today's action will finalize the Board's tentative action that was taken on February 9, 2016 pursuant to Agenda Item No. 16-6 and formally change the property's zoning classification.
