BACKGROUND:

Summary (continued)

The Riverside County Sheriff's Department's armored vehicle fleet was established in 2001 when it acquired a retired United States military vehicle known as a Peacekeeper. The Peacekeeper, manufactured in 1984, was acquired by the Department through military surplus. In 2005, three additional armored vehicles were purchased, two BEARCATS and one BULLDOG, bringing the total fleet of armored vehicles to four.

By 2012, County mechanics deemed the Peacekeeper vehicle no longer safe or repairable, and it was removed from service. This reduced the armored vehicle fleet by 25%. The Sheriff's Department's armored vehicle fleet has since remained at three vehicles, including two BEARCATS used as rescue vehicles and one BULLDOG used for armored transport of personnel. These three vehicles are relied upon and driven to all of Riverside County Sheriff's SWAT operations and have seen extensive use over the past ten years.

Over the past eighteen months, the three remaining armored vehicles have been sent in for repair twenty-seven times. Some of the repairs were extensive and took the vehicle out of service for lengthy periods of time. A review of the service and repair reports for the vehicles, to date, indicates the vehicle down time due to maintenance or repair can range from a day or two for minor repairs and scheduled maintenance service, to nearly two months or more for major repairs or engine rebuilds. Most of the vehicle maintenance and minor repairs are completed by Riverside County Fleet Services, but major repairs and engine rebuilds for the vehicles are completed by a local Ford authorized commercial fleet service center, which causes additional vehicle down time. As the three remaining vehicles continue to age, the wear and tear on the vehicles will continue and the need for on-going maintenance service and unanticipated repairs will increase. Factors such as high mileage and chassis wear due to the extreme weight of the armor will also increase the frequency of needed vehicle repair or service.

As the frequency of major repairs and maintenance service increases, the frequency and length of the vehicles being out of service due to repairs/maintenance also increases. The additional unavailability of the vehicles due to maintenance and unanticipated repair down time will cause significant safety gaps for the Riverside County Sheriff's Department and its ability to be properly equipped to handle its traditional law enforcement role or respond to the ever increasing threat of terrorist based events within our communities. The addition of the requested BEARCAT will minimize, if not eliminate, the possibility of SWAT being unable to properly provide the level of tactical intervention and/or support in a critical incident due to its armored vehicles being out of service for repair or maintenance service.

This mission of SWAT is to save lives. To save lives, SWAT uses armored vehicles like the BEARCAT as rescue vehicles, and in addition to transporting victims from hot zones, they provide safety for medical personnel treating victims inside the hot zone. The BEARCAT provides a safe position for crisis negotiators; a safe ability to deliver equipment, supplies and food/water during high risk operations. Armored vehicles also serve as a visual deterrent to de-escalate high risk operations.

Impact on Residents and Businesses

With the purchase of the armored vehicle, it will aid law enforcement in resolving high-risk events and provides a significate safety barrier for officers and civilians. There will be no negative impact on the budget, as payment for this vehicle will come from the Asset Forfeiture Sub Fund.

Contract History and Price Reasonableness

Lenco Armored Vehicles is the only manufacturer, distributor, authorized dealer and supplier of armored SWAT vehicles used in civilian law enforcement. Two other vendors were contacted, Vavistar Defense and Terradyne Inc. Both vendors do not manufacture a compact size vehicle, which is essential to maneuver through city streets and traffic. Also, Lenco products exceed the Department of State Level "E" ballistic specifications.

The purchase of the BEARCAT 4WD with level E ballistic armor is \$198,793. The cost for additional options including; diesel engine, intercom system, tire upgrade, military style cupola, ballistic windows, extreme heat reducing insulation, and sound reduction is \$65,482. The total purchase amount including tax and shipping is \$299,917. Lenco offers County pricing from their GSA Federal Contract No. GS07F0390M, which includes the discount amount of \$11,839. The Board of Supervisors has previously approved the purchase of two BEARCATS (03/14/06 3.22).

The below information is provided in support of my Department requesting approval for a sole source.

1. Supplier being requested: LENCO Armored Vehicles

2. Vendor ID: 59395

3. Supply/Service being requested: Request to purchase one tactical armored vehicle.

4. Alternative suppliers that can or might be able to provide supply/service and extent of market search conducted: LENCO Armored Vehicles are the only manufacturer, distributer, authorized dealer or supplier of an armored SWAT truck or its equivalent that is used in civilian law enforcement operations and environment. Its compact size provides a better method to maneuver through city streets and traffic.

Two other vendors were contacted, but their vehicles do not meet the Department's operational requirement. Vavistar Defense offers the Mine-Resistant Ambush Protected (MRAP) Assault Vehicle that is designed to withstand gunfire and explosives. The MRAP is a very large ballistic troop carrier designed for the U.S. military, and is not practical for SWAT or civilian law enforcement operations. Terradyne, Inc. manufactures armored vehicles but these vehicles are primarily used as wide perimeter vehicles and are not equipped with the maneuverability of the LENCO armored vehicles and other features required.

5. Unique features of the supply/service being requested from this supplier, which no alternative supplier can provide (if proprietary software or machinery, hardware, please provide a supporting letter from the manufacturer): LENCO possesses and utilizes proprietary equipment and designs to manufacture and outfit their armored vehicles necessary to meet the Department's operational mission for public safety. These armored vehicles from LENCO have been through a tremendous amount of ballistic and blast testing to validate the armoring systems being deployed on these vehicles. They meet or exceed the Department of State Level "E" ballistic specifications. LENCO vehicles are the only armored vehicle manufactures regulated by the federal government and approved by the U.S. State Department to ensure quality of ballistic materials and safety features.

Some unique features offered by LENCO includes:

A. Turning radius. The Lenco BearCat has a modified wheelbase and can turn within its own links. This feature provides the ability to maneuver within tight areas such as residential properties.

- B. Roof hatch. The Lenco BearCat is equipped with a ballistic roof hatch that opens and closes in zero gravity. Other manufacturer roof hatches are heavy and cumbersome and can be hazardous to personnel while operating.
- C_k Gun ports. One-handed operating gun ports.
- D. One piece side walls. This feature and design minimizes ballistic gaps.
- E. Frame reinforcement. The frame of the BearCat is reinforced and armored. This feature allows the continual operation if the fame is hit by gunfire.

These features are essential in providing officer safety in the line of duty when encountering hostile environment during rescue missions.

6. Reasons why my department requires these unique features and what benefit will accrue to the county: The threat of gun violence does not have boundary limitations. Lenco's passive multi-hit armor system provides ballistic protection and built with military specification. With the use of the Lenco BearCat, law enforcement officers, crisis negotiators, and tactical medics can safely roll face-to-face with an active shooter or barricaded gunman. In the past, negotiators and medics remained outside the "hot zone," several blocks away. The Lenco BearCat creates a significant safety barrier to the public and provides law enforcement officers who are required to contain violent situations a layer of safety, while in harm's way.

The Board had previously approved the purchase of two BearCat (3.22 2/2006). This vehicle is the standard operating platform used by Riverside County SWAT, both operationally and in training.

JUSTIFICATION AND APPROVAL FOR OTHER THAN FULL AND OPEN COMPETITION FOR THE ACQUISITION OF A NAME BRAND PRODUCT

- 1. The Office of Acquisition Management is conducting this acquisition for 13 Armored Assault Vehicles, on behalf of the Bureau of Diplomatic Security, Defensive Equipment/Armored Vehicle Division (DS/PSP/DEAV).
- 2. Nature and/or description of the action being approved. Purchase 13 armored assault vehicles that meet or exceed the Department of State (DoS) Level "E" ballistic specifications.
- 3. A description of the supplies or services required to meet the Department's needs. DS/PSP/DEAV has a requirement to acquire 13 armored assault vehicles for immediate deployment to Iraq and Afghanistan for security details. These vehicles must be armored to meet or exceed DoS Level "E" ballistic specifications. These vehicles must also have an armored gun turret mounted in the roof area of the vehicle.

REQUIREMENTS

- 1. MRAP Assault Vehicle with the following options: Diesel engine, export compliance, four wheel drive, Hutchinson VFI run flat system, rear auxiliary AC/Heating, intercom system, radio prep package, military cupola, gun mount for 240/.50 with pedestal, advance BMI MRP gunners seat, floor jack 3.5 ton, MRAP upgrade package to include upgraded wheels and tires, and V-shaped hull, blast seats (8 seats).
- 2. MRAP Assault Vehicle with VIP package and the following options: Diesel engine, export compliance, Back up Camera System, electric power, heated mirrors, high capacity rear AC/heating system, high intensity driving lights, intercom system, radio prep package, run-flat tires, spare tire with run-flat, high gloss exterior paint, V-shaped hull, blast seat (6 seats), and emergency escape hatch.
- 3. MRAP Assault Vehicle with the following options: Diesel engine, export compliance, four wheel drive, Hutchinson VFI run flat system, rear auxiliary AC/Heating, intercom system, radio prep package, MEDEVAC (4) litter pkg., floor jack 3.5 ton, MRAP upgrade package to include upgraded wheels and tires, and V-shaped hull, blast seats (2).
- 4. FOB delivery to Springfield, VA.

- 5. An identification of the statutory authority permitting other than full and open competition. DS/IP/SPC/WMD requests that this purchase fall under the authority of 41 USC 253(c)(1), FAR 6.304 (a)(2) and 8.405-6 (b)(1) (USC 501), for the purchase of a name brand product manufactured by LENCO Armored Vehicles, who is the only manufacturer of the Lenco BearCat, product number BC55003, a commercial item in accordance with FAR Part 12.
- 6. A demonstration that the proposed contractor's unique qualifications or the nature of the acquisition requires use of the authority cited. Presently, the DoS IDIQ contracts do not have these types of assault vehicles as line items. However, Lenco has been producing this vehicle for local and state agencies for years. In addition, Lenco fully understands DoS ballistic specifications and their experience with various armor systems will expedite the delivery of these vehicles in Iraq and Afghanistan.
- 7. A description of efforts made to ensure that offers are solicited from as many potential sources as is practicable. A notice will be publicized in accordance with 5.102(a)(6) on or about September 13, 2010 on GSA eBuy.com.
- 8. A determination by the Contracting Officer that the anticipated cost to the Government will be fair and reasonable. Per FAR 8.404(d), supplies offered on the schedule are listed at fixed prices. GSA has already determined the prices of supplies under schedule contracts to be fair and reasonable. Therefore, ordering activities are not required to make a separate determination of fair and reasonable pricing.
- 9. A description of the market survey conducted and the results or a statement of the reasons a market survey was not conducted. DS via AQM has issued five (5) different IDIQ contracts for the procurement of armored vehicles and none of these vendors produce this type of armored vehicle. DS has in the past purchased the M1114 HUMVEE from DOD vendors to satisfy our requirement for ballistic Level E specifications with a turret on the roof. Unfortunately, the military M114 HUMVEE has been discontinued. The replacement vehicle for M1114 is being produced by American General Corporation and this new armored vehicle is limited to only carrying five (5) personnel. DS has a minimum requirement to carry at least six (6) personnel at one time. The Lenco Bearcat VIP is capable of carrying six (6) personnel and the Lenco Bearcat is capable of carrying up to eight (8) personnel plus a position for the gunner in the turret. During our review of this new armored vehicle for DOD, the cost is double to the present cost of a Lenco Bearcat.

- 10. Any other facts supporting the use of other than full and open competition. The Lenco BearCat model contains highly specialized features which are specifically designed to accommodate our security operational needs in Iraq and Afghanistan and no other source can meet these requirements without substantial additional program costs and time, which will severely impact our mission. Lenco has developed and integrated mission critical applications and equipment essential to meeting our security goals in Iraq and Afghanistan. Lenco possesses and utilizes proprietary equipment and designs to manufacture and outfit these armored vehicles necessary for this mission and is the only known source that can meet the standardized logistic, training and program requirements for DS. These armored vehicles from Lenco have been through a tremendous amount of ballistic and blast testing to validate the armoring systems being deployed on these vehicles. These tests have been completed by the Department of Defense for the US Army and US Navy, H.P White Laboratory, an independent lab for numerous US Government Agencies and commercial armoring companies and the Department of State. By completing this order in a timely matter, DS will be able to ship these armored vehicles to Iraq and Afghanistan to support our security requirements and possibly save lives.
- 11. A listing of sources, if any, that expressed, in writing, an interest in the acquisition. The Armored Group expressed an interest in writing in response to GSA eBuy posting #RFQ516305.
- 12. A statement of the actions, if any, the agency may take to remove or overcome any barriers to competition before any subsequent acquisition for the supplies or services required. The barrier to full competition is the brand name specific requirements identified in paragraphs two (2) and three (3) above. Lenco Armored Vehicles is the only vendor that produces this type of vehicle and fully understands DOS and NIJ specifications for armoring these vehicles. At this time, the barrier cannot be removed unless there is a change in the operational needs identified by DS/PSP/DEAV contained herein. If operational needs or technological changes occur then this barrier may be lifted in the future. DS/PSP/DEAV and A/LM/AQM will continue to seek ways of removing any barriers to competition on future related acquisitions.
