RECOMMENDED MOTION (continued):

3. If the owner or whoever has possession of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials and accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance Nos. 348 and 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

1. An inspection was made on the subject property by Code Enforcement Officer Jacob Dietrich on July 9, 2013. The Inspection revealed excessive outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 348 and 541. The items included but were not limited to: green waste, televisions, furniture, scrap wood, metal, and plastic 55 gallon drums, ice chest, cardboard boxes, plastic trash bags, lattice, ladder, fire pit, vehicle seats, metal tool boxes, plastic crates, vacuums, book shelves, gas cans, hand truck, plastic tubs, trash cans, used tires, bicycles, yard tools, children's toys, lawn mowers, bedroom set, broken patio chairs, roofing materials, trash and debris, and miscellaneous items, of about 1,425 square feet.
2. There have been approximately nine (9) subsequent follow up inspections, with the last inspection occurring on February 17, 2016. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.
3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance, and potential impact on real estate values.

11 I, Jacob Dietrich, declare that the facts set forth below are personally known to me except to
12 the extent that certain information is based on information and belief which I believe to be true, and if
13 called as a witness, I could and would competently testify thereof under oath:

14 1. I am currently employed by the Riverside County Code Enforcement Department as a
15 Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting
16 property for violations and enforcement of the provisions of Riverside County Ordinances.

17 2. On July 9, 2013, I conducted an inspection of the real property described as 25874 2nd
18 Street, Hemet, Riverside County, California and further described as Assessor's Parcel Number 549-
19 173-022 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers
20 map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by
21 reference as Exhibit "A."

22 3. A review of County records and documents disclosed that THE PROPERTY is owned by
23 the Estate of Jeffrey Scott Johnson (hereinafter referred to as "OWNER"). A certified copy of the County
24 Equalized Assessment Roll for 2015-2016 tax year and a copy of the report generated from the County
25 Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as
26 Exhibit "B." The property is an improved parcel approximately 0.31 acres in size and is located within the
27 R-R (Rural Residential) zone classification. The parcel size is less than the minimum size requirements
28 and therefore does not allow any amount of outside storage on THE PROPERTY. Accumulated rubbish
is not permitted on any property within the unincorporated areas of the County of Riverside.

1 4. Based on the Lot Book Reports from RZ Title Service dated October 6, 2014, and updated
2 on February 19, 2015, August 10, 2015, and February 22, 2016, it is determined that other parties may
3 potentially hold a legal interest in THE PROPERTY, to wit: The Alton R. and Margie L. Morse Revocable
4 Trust #30526 dated August 9, 1991, Helen Maxwell, Internal Revenue Service, Lake Hemet Municipal
5 Water District, State of California Franchise Tax Board (hereinafter referred to as "INTERESTED
6 PARTIES"). True and correct copies of the Lot Book Report are attached hereto and incorporated herein
7 by reference as Exhibit "C."

8 5. On July 9, 2013, I conducted an inspection from the road right of way. I observed excess
9 outside storage and accumulated rubbish on THE PROPERTY. The outside storage of materials and
10 accumulated rubbish consisted of, but was not limited to: green waste, televisions, scrap wood, metal,
11 and plastic 55 gallon drums, ice chests, cardboard boxes, plastic trash bags, lattice, ladder, fire pit,
12 vehicle seats, metal tool boxes, plastic crates, vacuums, book shelves, gas cans, hand truck, plastic
13 tubs, trash cans, used tires, bicycles, yard tools, children's toys, lawn mowers, bedroom set, broken patio
14 chairs, roofing materials, trash and debris, and miscellaneous items, of about 1,425 square feet. This
15 condition causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth
16 in Riverside County Ordinance ("RCO") Nos. 348 and 541.

17 6. On July 9, 2013, a Notice of Violation was posted on THE PROPERTY.

18 7. On July 10, 2013, a Notice of Violation was mailed to OWNER by first class mail.

19 8. On February 17, 2015, a Notice of Violation was mailed to OWNER and INTERESTED
20 PARTY Helen Maxwell, by certified mail, return receipt requested.

21 9. On June 22, 2015, a Notice of Violation was mailed to INTERESTED PARTIES State of
22 California Franchise Tax Board, Internal Revenue Service, and Lake Hemet Municipal Water District, by
23 certified mail, return receipt requested.

24 10. A site plan and photographs depicting the conditions of THE PROPERTY are attached
25 hereto and incorporated herein by reference as Exhibit "D."

26 11. True and correct copies of each Notice issued in this matter and other supporting
27 documentation are attached hereto and incorporated herein by reference as Exhibit "E."

28 ///

1 12. There have been approximately nine (9) subsequent follow up inspections, with the last
2 inspection being February 17, 2016. Each inspection revealed the accumulated rubbish and excess
3 outside storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.

4 13. Based upon my experience, knowledge and visual observations, it is my determination
5 that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the
6 general public.

7 14. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO
8 Nos. 348 and 541.

9 15. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the
10 County Recorder, County of Riverside, State of California, on October 23, 2014, as Instrument Number
11 2014-0402738. A true and correct copy of which is attached hereto and incorporated herein by reference
12 as Exhibit "F."

13 16. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing
14 notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER and
15 INTERESTED PARTIES by first class mail and was posted on THE PROPERTY. True and correct
16 copies of the Notices, together with the Proofs of Service, and the Affidavit of Posting of Notices are
17 attached hereto and incorporated herein by reference as Exhibit "G."

18 17. The removal of all accumulated rubbish and excess outside storage of materials currently
19 on THE PROPERTY is required to bring THE PROPERTY into compliance with RCO Nos. 348 and 541,
20 and the Health and Safety Code.

21 18. Accordingly, the following findings and conclusions are recommended:

22 (a) the excessive outside storage of materials and accumulated rubbish on THE
23 PROPERTY to be deemed and declared a public nuisance; and

24 (b) the OWNER, or whoever has possession or control of THE PROPERTY, be
25 required to remove all outside storage and accumulated rubbish on THE PROPERTY in strict
26 accordance with the provisions of RCO Nos. 348 and 541.

1 (c) that if the materials and rubbish are not removed and disposed of in strict
2 accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541,
3 within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, the
4 outside storage of materials and accumulated rubbish may be abated and disposed of by representatives
5 of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon
6 receipt of owner's consent or a Court Order when necessary under applicable law.

7 (d) that reasonable costs of abatement, after notice and opportunity for hearing, shall
8 be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE
9 PROPERTY pursuant to Government Code Section 25845 and RCO No. 725.

10 I declare under penalty of perjury under the laws of the State of California that the
11 foregoing is true and correct.

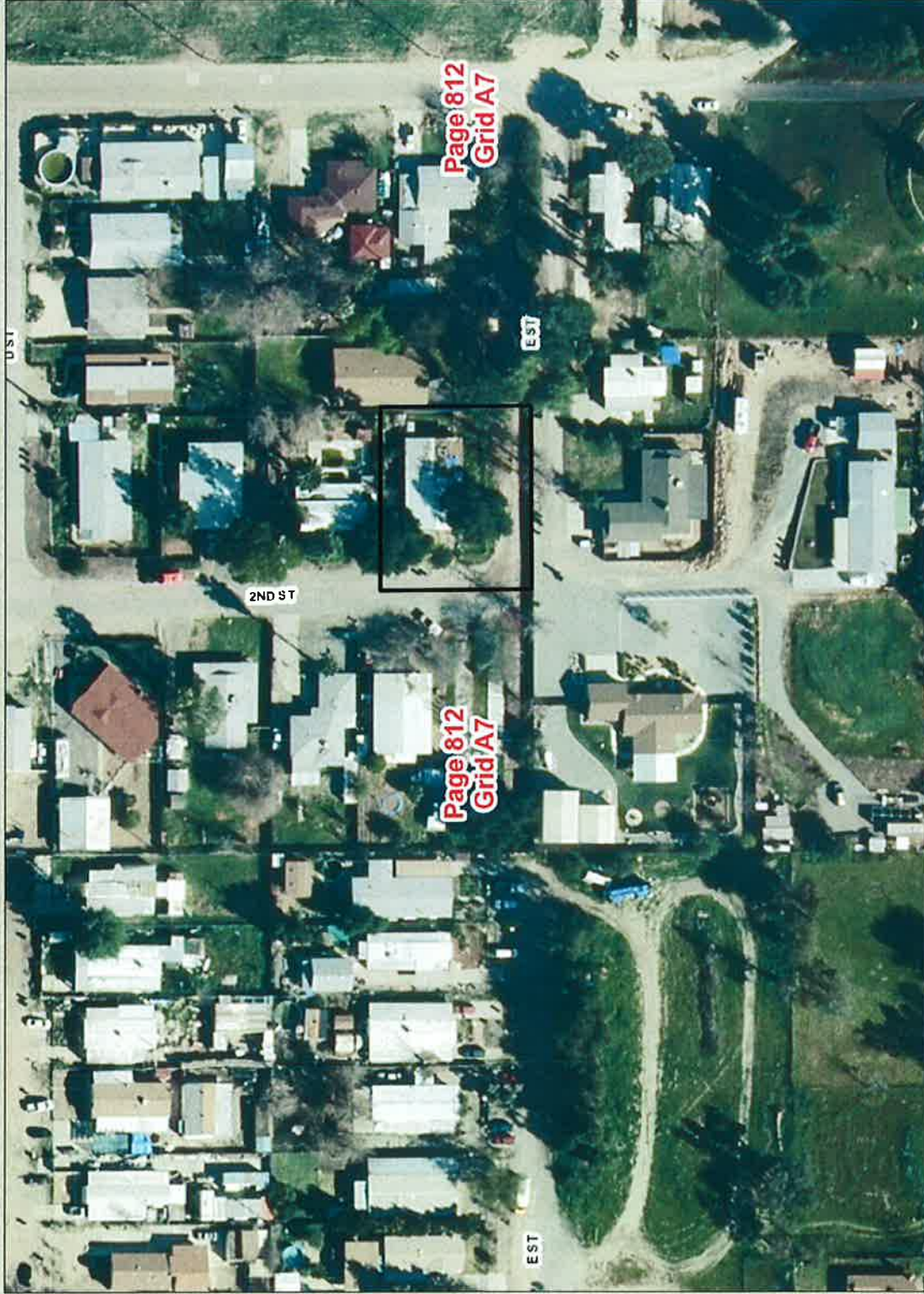

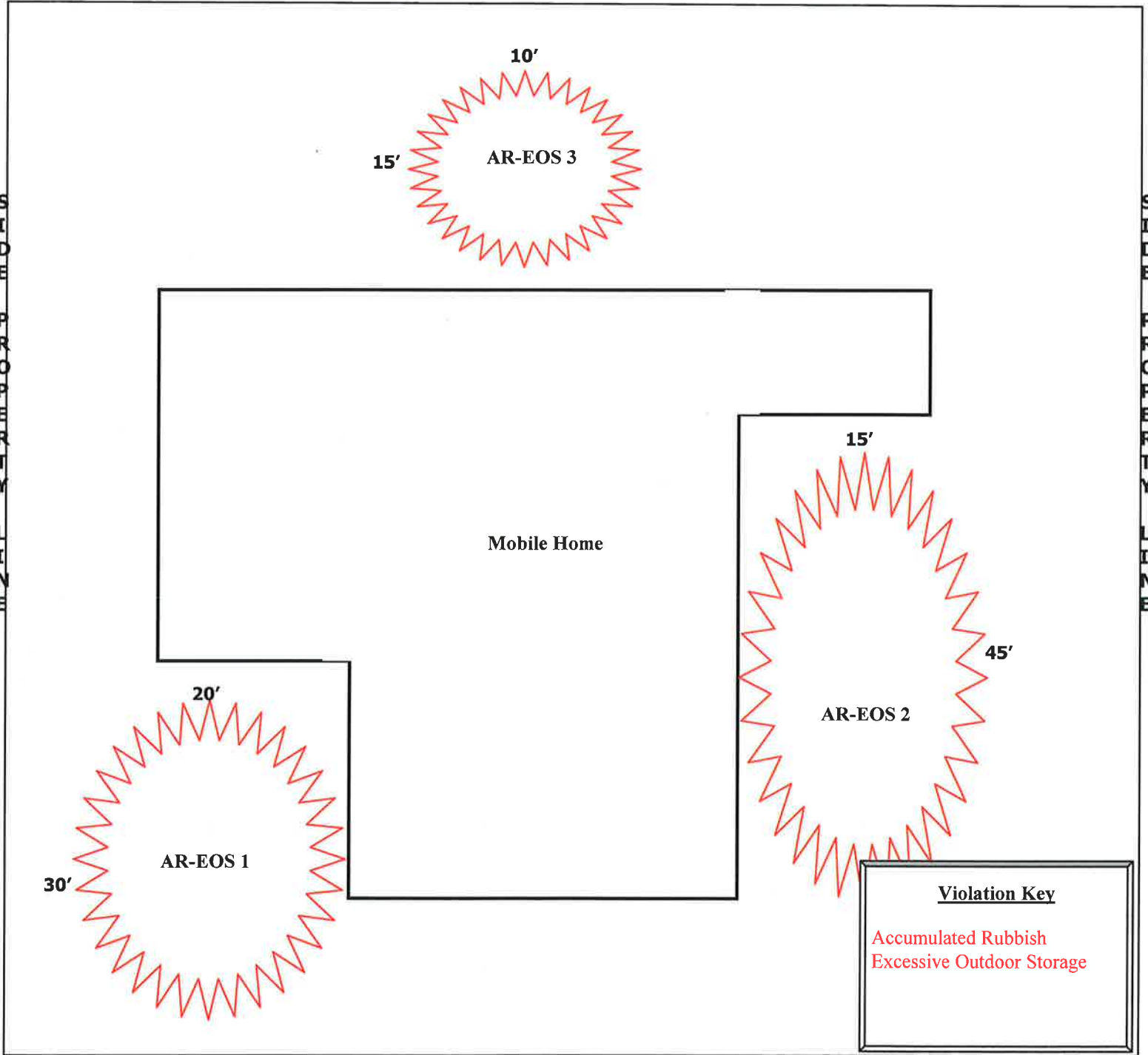
