BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the February 4, 2013 public auction sale. The deed conveying title to the purchasers at the auction was recorded April 1, 2013. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on April 24, 2013, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.

6. Authorize and direct the Treasurer-Tax Collector to transfer the unclaimed excess proceeds in the amount of \$10,287.32 to the county general fund pursuant to Revenue and Taxation Code Section 4674.

BACKGROUND:

Summary (continued)

Revenue and Taxation Code 4676 (b) states that the county shall make reasonable effort to obtain the name and last known mailing address of the parties of interest. Then, if the address of the party of interest cannot be obtained, the county shall publish notice of the right to claim excess proceeds in a newspaper of general circulation in the county as per Revenue and Taxation Code 4676 (c). The Treasurer-Tax Collector's Office has made it a policy to take the following actions to locate the rightful party of the excess proceeds.

- Examined title reports to notify all parties of interest attached to the parcel.
- Researched all last assessee's through the County's Property Tax System for any parties of interest.
- Used Accurant (people finder) to notify any new addresses that may be listed for our parties of interest.
- Advertised in newspapers for three consecutive weeks in the Desert Sun, Palo Verde Valley Times and the Press Enterprise referring any parties of interest to file a claim for the excess proceeds.
- Sent out a certified mailing within 90 days as required by Revenue and Taxation Code 4675.

According to Revenue and Taxation Code 4675 (a) Any party of interest in the property may file with the county a claim for the excess proceeds, in proportion to his or her interest held with others of equal priority in the property at the time of the sale, at any time prior to the expiration of the one year following the recordation of the Tax Collector's deed to the Purchaser, which was recorded on April 1, 2013.

The Treasurer-Tax Collector has received four claims for excess proceeds:

1. Claim from Sandra Wortham, heir to the Estate of Henrietta Wortham based on a Grant Deed recorded December 14, 1953 as Instrument No. 59350, an Affidavit under California Probate Code Section 13101 dated July 11, 2015 and the death certificate for Willie Wortham and Henrietta Ross Wortham.
2. Claim from Teresa Franklin, heir to the Estate of Henrietta Wortham based on a Grant Deed recorded December 14, 1953 as Instrument No. 59350, an Affidavit under California Probate Code Section 13101 dated July 11, 2015 and the death certificate for Willie Wortham and Henrietta Ross Wortham.

Claim from Found Extra Money, LLC agent for Gloria Lane, Successor Trustee to the Romalis Lane Trust based on an Authorization for Agent to Collect Excess Proceeds dated September 25, 2013, Grant Deed recorded June 17, 1992 as Instrument No. 223788, the Romalis Lane Trust and the death certificate of Romalis Lane.
4. Claim from David Brown, agent for Gloria P. Lane, Successor Trustee to the Romalis Lane Trust based on an Authorization for Agent to Collect Excess Proceeds dated March 25, 2014, Grant Deed recorded June 17, 1992 as Instrument No. 223788, the Romalis Lane Trust and the death certificate of Romalis Lane.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Sandra Wortham, heir to the Estate of Henrietta Wortham be awarded excess proceeds in the amount of \$5,143.66, Teresa Franklin, heir to the Estate of Henrietta Wortham be awarded excess proceeds in the amount of \$5,143.66, and Found Extra Money, LLC agent for Gloria Lane, Successor Trustee to the Romalis Lane Trust be awarded excess proceeds in the amount of \$10,287.32. The claim from David Brown, agent for Gloria P. Lane, Successor Trustee to the Romalis Lane Trust be denied since Gloria Lane had already authorized Found Extra Money, LLC to act as her agent. Since there are no other claimants the unclaimed excess proceeds for Tommy P. Lee and Cora Lee's portion in the amount of \$10,287.32 will be transferred to the county general fund. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

Impact on Citizens and Businesses

Excess proceeds are being released to the heirs to the last assesseees and transferred to the county general fund.

I have been asked by David Brown, attorney-in-fact of Mrs. Gloria Lane of 20110 Galway Avenue, Carson, California, to give my professional opinion on Mrs. Lane's claim to excess proceeds under section 4675 of the Revenue and Taxation Code for the above-referenced property in Riverside County.

Admittedly, this is not a clear cut situation for your office; not all documentation has been provided by Mrs. Lane. But there is enough, in my opinion, upon which your office may rely to disburse the excess proceeds so that an equitable resolution is reached. In a nutshell, as Mr. Lane's surviving spouse, and as Mr. Lane's successor trustee (see enclosed 'Declaration of Trust' page), Mrs. Lane is entitled to receive the excess proceeds from which she is then obligated to distribute pro rata shares to fellow beneficiaries and tenants in common.

As indicated on the enclosed death certificate of Romalis Lane, Gloria Lane was married to Mr. Lane at the time of his death. Also, at the time Mr. Lane took title to the above-referenced property in 1992, he was married to Mrs. Lane, thereby creating a community interest in the property. It is unclear whether Mr. Lane intended the above-referenced property to be included as part of his trust estate; but frankly it is irrelevant since Mrs. Lane is entitled to receive the property as either (a) successor trustee, or (b) as administrator of his intestate estate, or (c) as her share of community property.

Furthermore, although Mr. Lane had but a one-third interest as a tenant in common in the above-referenced property, Mrs. Lane is entitled to receive the full amount of excess proceeds under

§4675, from which she must account to the other co-tenants; for it is well-settled law that a cotenant who collects from third parties rents and other payments arising from the co-owned land must account to cotenants for the amounts received.

Finally, based on the January 22nd engagement letter from Mr. Brown to Mrs. Lane, along with the Limited Power of Attorney dated February 4th, Mr. Brown has been duly authorized to represent Mrs. Lane's interests under the rules set forth in §4675. Furthermore, Mr. Brown has met the requirements of disclosure required by the same section of the Revenue and Taxation Code. As such, Mrs. Lane's excess proceeds should be directed to Mr. Brown, Mrs. Lane's duly authorized agent at his mailing address, 1603 Copenhagen Drive, #6, Solvang, California 93463.
