### **BACKGROUND:**

#### **Summary**

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the August 20, 2013 public auction sale. The deed conveying title to the purchasers at the auction was recorded October 2, 2013. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on October 30, 2013 to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest. # BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received four claims for excess proceeds:

- Claim from RES-CA LWM, LLC based on a Construction Deed of Trust recorded August 22, 2006 as Instrument No. 2006-0617384, an Assignment of Real Estate Deed of Trust recorded April 7, 2010 as Instrument No. 2010-0159640, an Assignment of Real Estate Deed of Trust recorded December 30, 2011 as Instrument No. 2011-0578325 and a Judgment after Motion for Summary Adjudication of Issues filed March 27, 2014.
- Claim from the City of Banning based on a Notice of Pendency of Administrative Proceedings recorded January 9, 2009 as Instrument No. 2009-0011306, a Notice of Abatement/Assessment Lien recorded March 30, 2010 as Instrument No. 2010-0144065, a Notice of Pendency of Administrative Proceedings recorded April 19, 2010 as Instrument No. 2010-0178649

3. Claim from the State of California, Franchise Tax Board based on a Notice of State Tax Lien recorded September 22, 2009 as Instrument No. 2009-0493090.

4. Claim from Larry Moore based on a Grant Deed recorded August 22, 2006 as Instrument No. 2006-0617383.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that RES-CA LWM, LLC be awarded excess proceeds in the amount of \$38,576.66. Since the amount claimed by RES-CA LWM, LLC exceeds the amount of excess proceeds available, there are no funds available for consideration for the claims from the City of Banning, the State of California, Franchise Tax Board and Larry Moore. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

### INSTRUCTIONS FOR FILING CLAIM

(See Claim Form on Reverse Side)

The California Revenue and Taxation Code, Section 4675, states in part (paraphrased):

For the purposes of this article, parties of interest and their order of priority are:

- (a) First, lienholders of record prior to the recordation of the tax deed to the purchaser in the order of their priority; and
- (b) Then, any person with title of record to all or any portion of the property prior to the recordation of the tax deed to the purchaser.

If you consider yourself to be a party of interest in the sale of tax-defaulted property as defined above, please fill out the reverse of this form stating how you have determined your status as a party of interest. If you need help in filling out the form, please contact our office by telephone at 951-955-3842 mail, or in person.

You must attach copies of documents to support your claim as follows:

- 1. In case (a), attach a copy of your trust deed or other evidence of lien or security interest, along with a statement under penalty of perjury setting forth the original amount of the lien or interest, the total amount of payments received reducing the original amount of the lien or interest, and the amount still due and payable as of the date of the sale of the tax defaulted property by the Tax Collector.
- 2. In case (b), attach copies of any other documents (e.g., deed, certified death certificate, will, court order, etc.) supporting your claim.

PLEASE NOTE: We cannot, by law, begin processing of claims until one year has passed from the date of the deed to the purchaser. In order to receive consideration by the Riverside County Board of Supervisors, claims must be filed ON OR BEFORE THE EXPIRATION OF ONE YEAR following the date of the recording of the deed to the purchaser. Please see the "Date Deed to Purchaser Recorded" appearing on the attached notice (Form 117-170). The Tax Collector will submit a recommendation to the County Board of Supervisors as to what disposition should be made on your claim. Following the Board's review, the claim will either be approved or denied. The Clerk of the Board of Supervisors will notify you of the action taken by the Board. Should the claim be approved, the Auditor-Controller will issue a County warrant in payment. By law, the Auditor-Controller cannot issue a warrant in payment of the approved claim until 90 days following the action taken by the Board.

CONSTRUCTION DEED OF TRUST

THIS DEED OF TRUST Is dated August 3, 2006, among LAWRENCE W. MOORE, a Married Man as his Sole and Separate Property, whose address is 257 E. 6TH STREET STE B, BEAUMONT, CA 92223 ("Trustor"); 1ST CENTENNIAL BANK, whose address is REAL ESTATE LENDING DEPARTMENT #56, 101 E. REDLANDS BLVD., SUITE 106, REDLANDS, CA 92373 (referred to below sometimes as "Lender" and sometimes as "Beneficiary"); and 1ST CENTENNIAL BANK, whose address is 101 E. REDLANDS BLVD., SUITE 106, REDLANDS, CA 92373 (referred to below as "Trustee").

CONVEYANCE AND GRANT. For variable consideration, Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, for the benefit of Lender as Beneficiary, all of Trustor's right, fille, and interest in and to the following described rest property, logather with all existing or subsequently eracted or affixed buildings, improvements and factures; all seasoneris, rights of way, and appurtenances; all water, water rights and ditch rights (including stock in utilities with clich or irrigation highle); and all other rights, royalles, and profits relating to the rest property, including without limitation all minerals, oil, gas, geothermal and similar matters, (the "Real Property") located in RIVERSIDE County, State of California;

See EXHIBIT "ONE", which is attached to this Deed of Trust and made a part of this Deed of Trust as if fully set forth herein.

The Real Property of its address is commonly known as PORTIONS OF LOTS 3 AND 4 SAN GORGONIO AVENUE, BANNING, CA 92220. The Assessor's Parcel Number for the Real Property is 641-300-001-2 & 641-300-002-3.

Trustor presently assigns to Lender (also known as Beneficiary in this Deed of Trust) all of Trustor's right, fille, and interest in and to all present and future leases of the Property and all Berts from the Property. This is an absolute assignment of Bents made in connection with an obligation secured by real property pursuant to California Civil Code Section 2938. In addition, Trustor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Bents.

THIS DEED OF THUST, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS GIVEN TO SECURE (A) PAYMENT OF THE INDESTEDNESS AND (B) PERFORMANCE OF ANY AND ALL OBLIGATIONS OF THE TRUSTOR UNDER THE MOTE, THE RELATED DOCUMENTS, AND THIS DEED OF TRUST. THIS DEED OF TRUST, INCLUDING THE ASSIGNMENT OF RENTS AND THE SECURITY INTEREST IN THE RENTS AND PERSONAL PROPERTY, IS ALSO GIVEN TO SECURE ANY AND ALL OF TRUSTOR'S OBLIGATIONS UNDER THAT CERTAIN CONSTRUCTION LOAN AGREEMENT BETWEEN TRUSTOR AND LENDER OF EVEN DATE HEREWITH. ANY EVENT OF DEFAULT UNDER THE CONSTRUCTION LOAN AGREEMENT, OR ANY OF THE RELATED DOCUMENT'S REFERRED TO THEREIN, SHALL ALSO BE AN EVENT OF DEFAULT UNDER THIS DEED OF TRUST, THIS DEED OF TRUST, THIS DEED OF TRUST, THIS DEED OF TRUST.

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Deed of Trust, Trustor shall pay to Lender all amounts secured by this Deed of Trust as they become due, and shall strictly and in a limity manner perform all of Trustor's obligations under the Note, this Deed of Trust, and the Related Documents.

CONSTRUCTION MORTGAGE. This Deed of Trust is a "construction mortgage" for the purposes of Sections 9-334 and 2A-309 of the Uniform Commercial Code, as those sections have been adopted by the State of California.

POSSESSION AND MAINTENANCE OF THE PROPERTY. Trustor agrees that Trustor's possession and use of the Property shall be governed by the following provisions:

Possession and Use. Until the occurrence of an Event of Default, Trustor may (1) remain in possession and control of the Property; (2) use, operate or manage the Property; and (3) collect the Renis from the Property.

Duty to Maintain. Trustor shall maintain the Properly in tenantable condition and promptly perform all repairs, replacements, and maintenance necessary to preserve its value.

Compliance With Environmental Laws. Truster represents and warrants to Lender that: (1) During the period of Truster's ownership of the Property, there has been no use, generation, manufacture, storage, treatment, disposal, release or threatened release of any Hazardous

Substance by any person on, under, about or from the Property; (2) Trustor has no knowledge of, or reason to believe that there has been, except as previously disclosed to and acknowledged by Lender in writing, (a) any breach or vidation of any Environmental Laws, (b) any use, generation, manufacture, storage, treatment, disposal, release or itreatened release of any Hazardous Substance on, under, about or from the Property by any prior owners or occupants of the Property, or (o) any actual or threatened stigation or claims of any kind by any person relating to such matters; and (3) Except as previously disclosed to and acknowledged by Lender in writing, (e) neither Trustor nor any tenant, contractor, agent or other authorized user of the Property shall use, generale, manufacture, store, treat, dispose of or release any tesardous Substance on, under, about or from the Property; and (b) any such activity shall be conducted in compliance with all applicable tederal, state, and local laws, regulations and ordinances, including without limitation at Environmental Laws. Trustor authorizes Lender and determine compliance of the Property to make such inspections and tests, at Trustor's expense, as Lender may deem appropriate to determine compliance of the Property with this section of the Deed of Trust. Any Inspections or tests made by Lender shall be for Lender's purposes only and shall not be construed to create any responsibility or itability on the part of Lender in Trustor or to any other person. The representations and warranties contained herein are based on Trustor's due difigence in investigating the Property for Hazardous Substances. Trustor hareby (1) releases and waives any tuttere claims against any and all claims, tosses, liabilities, damages, penalties, and expenses which Lender may checity or indirective or substance or threatened of this section of the Deed of Trust or as a consequence of any use, generation, manufacture, storage, deposal, release or threatened release occurring prior to Trustor's own Properly, whalter by foreclosure or otherwise.

Nulsance, Waste. Trustor shall not eause, conduct or permit any nulsance nor commit, permit, or suffer any stipping of or waste on or to the Property or any portion of the Property. Without limiting the generality of the toregoing, Trustor will not remove, or grant to any other party the right to remove, any timber, minerals (including di and gas), outl, clay, scoria, soil, gravet or rock products without Lender's prior

Removal of Improvements. Trustor shall not demotish or remove any improvements from the Real Property without Lander's prior written consent. As a condition to the removal of any improvements, Lender may require Trustor to make arrangements satisfactory to Lender to replace such improvements with improvements of at least equal value.

Lender's Right to Enter. Lender and Lender's agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interests and to inspect the Real Property for purposes of Trustor's compliance with the terms and conditions of this Deed

Compliance with Governmental Requirements. Trustor shall promptly comply with all taws, ordinances, and regulations, now or hereafter in effect, of all governmental authorities applicable to the use or occupancy of the Property, including without limitation, the Americans With Disabilities Act. Trustor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Trustor has notified Lender in writing prior to doing so and so long as, in Lender's sole opinion, Lender's interests in the Property are not jeopardized. Lender may require Trustor to post adequate security or a surely bond, reasonably satisfactory to Lender, to protect Lender's interest.

Duty to Protect. Trustor agrees neither to abandon or leave unattended the Property. Trustor shall do all other acts, in addition to those acts sat both above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the

Construction Loan. If some or all of the proceeds of the loan creating the Indebtedness are to be used to construct or complete construction of any improvements on the Property, the Improvements shall be completed no later than the malurity date of the Note (or such sariler date as Lender may reasonably establish) and Truster shall pay in full all costs and expenses in connection with the work. Lender will disburse loan proceeds under such terms and conditions as Lender may deem reasonably necessary to insure that the interest created by this Deed of Trust shall have priority over all possible lieus, including those of material suppliers and workmen. Lender may require, among other things, that disbursement requests be supported by receipted bills, expense addaylis, waivers of thems, construction progress reports, and such other documentation as Lender may reasonably request.

DUE ON SALE — CONSENT BY LENDER. Lender may, at Lender's option, declare immediately due and payable all sums secured by this Deed of Trust upon the sale or transfer, without Lender's prior written consent, of all or any part of the Real Property, or any interest in the Real Property, or any interest in the Real Property whether legal, beneficial or equitable, whether votunitary or involuntary; whether by outright sale, deed, installment sale contract, land contract, contract for deed, leasehold interest with a term greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any land trust holding tille to the Real Property, or by any other method of conveyance of an interest in the Real Property. However, this option shall not be exercised by Lender if such exercise is prohibited by applicable law.

TAXES AND LIENS. The following provisions relating to the taxes and tiens on the Property are part of this Deed of Trush

Payment. Trustor shall pay when due (and in all events at least len (10) days prior to delinquency) all loxes, special taxes, assessments, charges (including water and sewer), fines and impositions levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Trustor shall maintain the Property ree of all tens having priority over or equal to the Interest of Lander under this Deed of Trust, except for the lien of taxes and essessments not due and except as otherwise provided in this Deed of Trust.

Right to Contest. Trustor may withhold payment of any tax, assessment, or claim in connection with a good talth dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized. It alter arises or is filed as a result of nonpayment, Trustor shall within fifteen (16) days after the lien arises or, it alter is filed, within fifteen (16) days after Trustor has notice of the tling, secure the discharge of the lien, or it requested by Lender, deposit with Lender cash or a sufficient corporate surely bond or other security satisfactory to Lender In a amount sufficient to discharge the lien plus any costs and attorneys fees, or other charges that could accrue as a result of a loreolosure or sale under the lien. In any contest, Trustor shall detend lises and Lender and shall salisty any adverse judgment before enforcement against the Property. Trustor shall name Lender as an additional obligee under any surely bond turnished in the contest proceedings.

Evidence of Payment. Trustor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes of assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the

Notice of Constitution. Trustor shall notify Lander at least diffeen (15) days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any mechanic's lien, materialments lien, or other lien could be asserted on account of the work, services, or materials. Trustor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Trustor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Deed of Trust,

Maintenance of Insurance. Trustor shall produce and maintain policies of the insurance with standard extended coverage endorsements on Maintenance of Insurance. Trustor shall produce and maintain policies of the Insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering at improvements on the feet Property in an amount sufficient to avoid application of any collectrance clause, and with a standard mortgages clause in layor of Lender. Trustor shall also produce and maintain comprehensive general liability insurance in such coverage amounts as Lender may request with Trustee and Lender being named as additional insurance, insurance, insurance policies. Additionally, Trustor shall maintain such other insurance, including but not limited to hazard, business interruption, and botter insurance, as Lender may reasonably require. Notwithstanding the freegoing, in no event shall Trustor be required to provide hazard insurance in excess of the replacement value of the improvements on the fleat Property. Policies shall be written in form, amounts, coverages and basis reasonably acceptable to Lender and Issued by a company or companies reasonably acceptable to Lender, Trustor, upon request of Lender, will deliver to Lender from time to time the policies or certificates of insurance in form satisfactory to Lender, including stipulations that coverages will not be cancelled or diminished without at least ten (10) days prior written notice to Lender. Each insurance policy also shall include an endorsement providing that coverage in favor of Lender will not be impaired in any way by any act, omission or default of Trustor or any other person. Should the fleat Property be located in an area designated by the Director of the Federal Emergency Management Agency as a special flood hazard area, Trustor agrees to obtain and maintain Federal Flood insurance, if availables. omission of details of trouter of any other person. Should the real property be located in an area designated by the birector of the rederal Emergency Management Agency as a special flood hazard area, Trustor agrees to obtain and maintain Federal Flood insurance, it available, within 46 days after notice is given by Lender that the Property is located in a special flood hazard area, for the full unpaid principal belance of the loan and any prior flens on the property securing the loan, up to the medimum policy limits set under the National Flood Insurance Program, or as otherwise required by Lender, and to meintain such insurance for the term of the loan.

Application of Proceeds. Trustor shall promptly notify Lender of any less or damage to the Property. Lender may make proof of loss if Trustor fells to do so within fifteen (15) days of the casualty. If in Lender's sole judgment Lender's security interest in the Property has been impaired, Lender may, at Lender's election, receive and relate the proceeds of any insurance and apply the proceeds to the reduction of the indebtedness, payment of any lien effecting the Property, or the restoration and repair of the Property. If the proceeds are to be applied to restoration and repair, Trustor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Trustor from the proceeds for the reasonable cost of repair or restoration if Trustor is not in default under this Dead of Trust. Any proceeds which have not been discussed within 180 days after their receipt and which Lander has not committed to the repair or restoration of the Property shall be used first to pay any amount owing to Lander under this Dead of Trust, then to pay accounted interest, and the remainder, if any, shall be applied to the principal balance of the indebtedness. If Lander holds any proceeds after payment in full of the indebtedness, such proceeds shall be paid to Trustor as Trustor's interests may ancest.

Trusfor's Report on insurance. Upon request of Lender, however not more than once a year, Trusfor shall turnish to Lender a report on each existing policy of insurance showing: (1) the name of the insurer; (2) the risks insured; (3) the amount of the policy; (4) the property insured, the then ourrent replacement value of such property, and the manner of determining that value; and (5) the expiration date of the policy. Trusfor shall, upon request of Lender, have an independent appraiser satisfactory to Lender determine the cash value replacement cost of the Property.

LENDER'S EXPENDITURES. If any action or proceeding is commenced that would materially affect Lender's interest in the Property or if Trustor LENDER'S EXPENDITURES. If any sotion or proceeding is commenced that would materially affect Lender's interest in the Property or if Trustor falls to comply with any provision of this Deed of Trust or any Related Documents, including but not limited to Trustor's fallure to discharge or pay when due any amounts Trustor is required to discharge or pay under this Deed of Trust or any Related Documents, Lender on Trustor's behalf may (but shall not be obligated to) take any sotion that Lender deems appropriate, including but not limited to discharging or paying all taxes, liens, security interests, encumbrances and other obtains, at any time levied or placed on the Property and paying all costs for insuring, maintaining and preserving the Property. All such expenditures incurred or paid by Lender for such purposes will then bear interest at the rate charged under the Note from the date incurred or paid by Lender to the date of repayment by Trustor. All such expenses will become a part of the indebtadness and, at Lender's option, will (A) be payable on demand; (B) be added to the balance of the Note and be apportioned among and be payable with any installment payments to become due during either (1) the term of any applicable insurance policy; or (2) the remaining term of the Note; or (C) be treated as a balloon payment which will be due and payable at the Note's maturity. The Deed of Trust also will secure payment of these amounts. Such right shall be in addition to all other rights and remedies to which Lender may be entitled upon Default.

WARRANTY: DEFENSE OF TITLE. The following provisions relating to ownership of the Property are a part of this Deed of Trust:

Title. Trustor warrants that: (a) Trustor holds good and marketable life of record to the Property in see simple, tree and clear of all tiens and encumbrances other than those sel torth in the Real Property description or in any title insurance policy, title report, or final title opinion issued in favor of, and accepted by, Lender in connection with this Deed of Trust, and (b) Trustor has the full right, power, and authority to execute and deliver this Deed of Trust to Lender,

Detense of Title. Subject to the exception in the paragraph above, Trustor warrants and will forever detend the title to the Property against the lawful dalms of all persons. In the event any action or proceeding is commenced that questions Trustor's little or the interest of Trustor and Int but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of Lender's own choice, and Trustor will deliver, or cause to be delivered, to Lender such instruments as Lender may request from time to time to permit such

Compliance With Laws. Truster warrants that the Property and Truster's use of the Property compiles with all existing applicable laws, ordinances, and regulations of governmental authorities.

Survivat of Representations and Warranties. All representations, warranties, and agreements made by Trustor in this Deed of Trust shall

survive the execution and delivery of this Deed of Trust, shall be continuing in nature, and shall remain in full force and effect until such time as Trustor's indebtedness shall be paid in full.

CONDEMNATION. The following provisions relating to sminent domain and inverse condemnation proceedings are a part of this Deed of Trust;

Proceedings. If any eminent domain or inverse condemnation proceeding is commenced affecting the Property, Trustor shall promptly and inverse condemnation proceeding is commenced affecting the Property, Trustor shall promptly take such sleps as may be necessary to pursue or defend the action and obtain the award. Trustor may be the nominal party in any such proceeding, but Lender shall be entitled, at its election, to participate in the proceeding and to be represented in the proceeding by course of its own choice, and Trustor will deliver or cause to be delivered to Lender such instruments and documentation as may be requested by Lender from time to time to participation.

Application of Net Proceeds. If any award is made or settlement entered into in any condemnation proceedings affecting all or any part of the Property or by any proceedings or purchase in tieu of condemnation, Landar may at its sleetlen, and to the extent permitted by law, require that all or any portion of the award or settlement be applied to the indebtedness and to the repayment of all reasonable occis, expenses, and attorneys' tees incurred by Trustee or Lender in connection with the condemnation proceedings.

IMPOSITION OF TAXES, FEES AND CHARGES BY GOVERNMENTAL AUTHORITIES. The following provisions retaining to governmental laxes, sees and otherges are a part of this Dead of Trust:

Current Taxes, Fees and Charges. Upon request by Lander, Trustor shall execute such documents in addition to this Deed of Trust and lake whatever other action is requested by Lander to perfect and continue Lander's lien on the Real Property. Trustor shall relimbures Lander for all laxes, as described below, together with all expenses incurred in recording, perfecting or continuing this Deed of Trust, including without similation all taxes, fees, documentary stamps, and other charges for recording or registering this Deed of Trust.

Taxes. The following shall constitute laxes to which this section applies: (1) a specific lax upon this type of Deed of Trust or upon all or any part of the Indebtechness secured by this Deed of Trust; (2) a specific tax on Trustor which Trustor is authorized or required to deduct from payments on the Indebtechness secured by this type of Deed of Trust; (3) a tax on this type of Deed of Trust chargeable against the Lender or the holder of the Note; and (4) a specific tax on all or any portion of the Indebtechness or on payments of principal and interest made by Trustor.

Subsequent Taxes. If any lax to which this section applies is enacted subsequent to the date of this Dead of Trust, this event shall have the same effect as an Event of Default, and Lander may exercise any or all of its available remedies for an Event of Default as provided below unless Trustor either (1) pays that tax before it becomes definquent, or (2) contests the tax as provided above in the Taxes and Liens section and deposits with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lender.

SECURITY AGREEMENT; FINANCING STATEMENTS. The following provisions retailing to this Deed of Trust as a security agreement are a part of this Deed of Trust:

Security Agreement. This instrument shall constitute a Security Agreement to the extent any of the Property constitutes fixtures, and Lender shall have all of the rights of a secured party under the Uniform Commercial Code as amended from time to time.

Security interest. Upon request by Lender, Trustor shall take whatever action is requested by Lender to perfect and continue Lender's security interest in the Rents and Personal Property. Trustor shall reimburse Lender for all expenses incurred in perfecting or continuing this security interest. Upon default, Trustor shall not remove, sever or detach the Personal Property from the Property. Upon default, Trustor shall assemble any Personal Property not affixed to the Property in a manner and at a place reasonably convenient to Trustor and Lender and make it available to Lender within three (3) days after receipt of written demand from Lender to the extent permitted by applicable law.

Addresses. The malling addresses of Trustor (debtor) and Lender (secured party) from which information concerning the security interest granted by this Dead of Trust may be obtained (each as required by the Uniform Commercial Code) are as stated on the first page of this Dead of Trust.

FURTHER ASSURANCES; ATTORNEY-IN-FACT. The following provisions relating to further assurances and afterney-in-fact are a part of this Deed of Trust:

Further Assurances. At any time, and from time to time, upon request of Lender, Trustor with make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and when requested by Lender, cause to be fited, recorded, relied, or resecuted, as the case may be, at such times and in such offices and places as Lender may deem appropriate, any and all such inortgages, deeds of trust, security deeds, security agreements, linancing statements, confinuation statements, instruments of further assurance, certificates, and other documents as may, in the sole option of Lender, be necessary or desirable in order to effectuate, complete, perfect, confinue, or preserve (1) Trustor's obligations under the Note, this Deed of Trust, and the Related Documents, and (2) the liens and security interests created by this Deed of Trust as tirst and prior tiens on the Property, whether now owned or hereafter acquired by Trustor. Unless prohibited by law or Lender agrees to the contrary in writing. Trustor shall reimburse Lender for all costs and expenses incurred in connection with the matters reterred to in this paragraph.

Attorney-in-Fact. If Trustor falls to do any of the things referred to in the preceding paragraph, Lender may do so for and in the name of Trustor and at Trustor's expense. For such purposes, Trustor hereby inevocably appoints Lender as Trustor's attorney-in-fact for the purpose of making, executing, delivering, filling, recording, and doing all other things as may be necessary or desirable, in Lender's sole opinion, to accomplish the maiters referred to in the preceding paragraph.

PARTIAL RELEASES. Lender shall execute partial releases of the lien of this Deed of Trust upon the following conditions: NET PROCEEDS BUT NOT LESS THAN 100% OF THE ALLOCATED LOAN AMOUNT (Appraised Value x 69,00% x 100%).

FULL PERFORMANCE. If Trustor pays all the indebtedness when due, and otherwise performs all the obligations imposed upon Trustor under this Dead of Trust, Lender shall execute and deliver to Trustoe a request for full reconveyance and shall execute and deliver to Trustor suitable sistements of termination of any financing statement on file evidencing Lender's security interest in the Rents and the Personal Property. Lender may charge Trustor a reasonable reconveyance see at the time of reconveyance.

EVENTS OF DEFAULT. Each of the tollowing, at Lander's option, shall constitute an Event of Default under this Deed of Trust:

Payment Default. Trustor falls to make any payment when due under the indebtedness.

Other Detautie. Trustor fails to comply with or to perform any other term, obligation, covenant or condition contained in this Deed of Trust or in any of the Related Documents or to comply with or to perform any term, obligation, covenant or condition contained in any other agreement between Lender and Trustor.

Compilance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Deed of Trust, the Note or in any of the Related Documents.

Default on Other Payments. Failure of Trustor within the time required by this Deed of Trust to make any payment for taxes or insurance, or any other payment necessary to prevent filing of or to effect discharge of any lien.

Default in Favor of Third Parties. Should Trustor default under any loan, extension of credit, security agreement, purchase of sales agreement, for any other agreement, in favor of any other orditor or person that may materially affect any of Trustor's property or Trustor's ability to repay the indebtedness or perform their respective obligations under this Deed of Trust or any of the Related Documents.

Faise Statements. Any warranty, representation or statement made or furnished to Lender by Trustor or on Trustor's behalf under this Deed of Trust or the Related Documents is taken or misleading in any material respect, either now or at the time made or furnished or becomes taken or misleading at any time thereafter.

Defective Collateralization. This Deed of Trust or any of the Related Documents ceases to be in full force and effect (including failure of any collateral document to create a valid and perfected security interest or filen) at any time and for any reason.

Death or insolvency. The death of Trustor, the insolvency of Trustor, the appointment of a receiver for any part of Trustor's property, any assignment for the benefit of creditors, any type of creditor workoul, or the commencement of any proceeding under any bankrupley or insolvency taws by or against Trustor.

Creditor or Forfeiture Proceedings. Commencement of treolosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or any other melhod, by any creditor of Trustor or by any governmental agency against any properly securing the indebtedness. This includes a garnishment of any of Trustors accounts, including deposit accounts, with Lender. However, this Event of Default shall not apply if there is a good falln dispute by Trustor as to the validity or reasonableness of the daim which is the basis of the oracitor or torfeiture proceeding and if Trustor gives Lender witten notice of the oracitor or forfeiture proceeding and deposits with Lender mortes or a surety band for the oracitor or forfeiture proceeding, in an amount determined by Lender, in its sole discretion, as being an adequate reserve or bond for the dispute.

Breach of Other Agreement. In the event of a death, Lender, at its option, may, but shall not be required to, permit the guarantor's estate to assume unconditionally the obligations arising under the guaranty in a manner satisfactory to Lender, and, in doing so, ourse any Event of Default.

Adverse Change. A material adverse change occurs in Trustor's financial condition, or Lender believes the prospect of payment or performance of the Indebtedness is impaired.

insecurity. Lender in good faith believes itself insecure.

Right to Cure. If any default, other than a detault in payment is curable and if Trustor has not been given a notice of a breach of the same provision of this beed of Trust within the preceding twelve (12) months, if may be cured if Trustor, after receiving written notice from Lender demanding cure of such detault: (1) cures the detault within fifteen (15) days; or (2) If the cure requires more than fifteen (15) days, immediately inflates steps which tender deems in Lender's sole discretion to be sufficient to cure the default and thereafter continues and completes all reasonable and necessary steps sufficient to produce completes as soon as reasonably practical.

RIGHTS AND REMEDIES ON DEFAULT. If an Event of Default coours under this Deed of Trust, at any time thereafter, Trustee or Lender may exercise any one or more of the following rights and remedies:

Election of Remedies. Ejection by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or to take action to perform an obligation of Trustor under this Deed of Trust, after Trustor's failure to perform, shall not affect Lender's right to declare a default and exercise its remedies.

Porediosure by Sale. Upon an Event of Default under this Deed of Trust, Beneficiary may declare the entire indebtedness secured by this Deed of Trust immediately due and payable by delivery to Trustee of written declaration of default and demand for sale and of written notice of default and of election to cause to be sold the Property, which notice Trustee shall cause to be filed for record. Beneficiary also shall deposit with Trustee this Deed of Trust, the Note, other documents requested by Trustee, and all documents evidencing expenditures secured hereby. After the lopse of such time as may then be required by law following the recordation of the notice of default, and notice of sale having been given as then required by law, Trustee, without demand on Trustor, shall sell the Property at the time and place fixed by it in the notice of sale, either as a whole or in separate parcels, and in such order as it may determine, at public autotion to the highest bidder for cash in lawful money of the United States, payable at time of sale. Trustee may postpone sale of all or any portion of the Property by public announcement at such time and place of sale, and from time to time increation may postpone such sale by public announcement at time fixed by the preceding postponement in accordance with applicable law. Trustee shall deliver to such purchaser its deed conveying the Property so sold, but without any covenant or warranty, express or implied. The recitals in such deed of any matters or toots shall be conclusive proof of the truthfulness thereof. Any person, including Trustor, Trustee or Sensition of the property at such sale. After deducting all costs, fees and expenses of Trustee and of this Trust, including cost of evidence of title in connection with sale. Trustee shall copyly the proceeds of sale to payment of: all sums expended under the terms hereof, not then repetic, with accrued interest at the amount allowed by law in effect at the date hereof; all other sums then secured hereby; and the remainder, it a

Judicial Foreclosure. With respect to all or any part of the Real Property, Lender shall have the right in lieu of toreclosure by power of sale

UCC Remedies. With respect to all or any part of the Personal Property, Lander shall have all the rights and remedies of a secured party under the Uniform Commercial Code, including without limitation the right to recover any deficiency in the manner and to the full extent provided by California law.

Collect Rents. Lender shall have the right, without notice to Trustor to take possession of and manage the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness. In furtherence of this right, Lender may require any tenant or other user of the Property to make payments of rent or use tees directly to Lender, if the Rents are collected by Lender, then Trustor irrevocably designates Lender as Trustor's altomey—in—fact to endorse instruments received in payment thereof in the name of Trustor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall salisty the obligations for which he payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Appoint Receiver. Lander shall have the right to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the indebtedness. The receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the indebtedness by a substantial amount. Employment by Lender shall not disquality a person from serving as a receiver.

Tenancy at Sufference. If Trustor remains in possession of the Property after the Property is sold as provided above of Lender of the becomes shifted to possession of the Property upon default of Trustor, Trustor shall become a tenant at sufference of Lender or the purchaser of the Property and shall, at Lender's option, either (1) pay a reasonable rental for the use of the Property, or (2) vecate the Property immediately upon the demand of Lender.

Other Remedies. Trustee or Lander shall have any other right or remedy provided in this Deed of Trust or the Note or by law.

Notice of Sale. Lender shall give Trustor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least ten (10) days before the time of the sale or disposition. Any sale of the Personal Property may be made in continuiton with any sale of the Real Property.

Sale of the Property. To the extent permitted by applicable law, Trustor hereby walves any and all rights to have the Property marshalled. In exercising its rights and remedies, the Trustee or Lender shall be tree to selt all or any part of the Property logether or separately, in one sale or by separate sales. Lender shall be shilled to bid at any public sale on all or any portion of the Property.

Attenteys' Fees; Expenses. If Lender Institutes any suit or action to entry of the terms of this Deed of Trust, Lender shall be entitled to recover such sum as the court may adjudge reasonable as atterneys' fees all trial and upon any appeal. Whether or not any court action is involved, and to the extent not prohibited by law, all reasonable expenses Lender Incurs that in Lender's opinion are necessary at any time tor the proteotion of its interest or the enforcement of its rights shall become a part of the indebtedness payable on demand and shall bear interest at the Note rate from the date of the expenditure unit repaid. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's attempts' fees and Lender's legal expenses, whether or not there is a lawsuit, including attempts' fees and expenses to bankruptoy proceedings (including efforts to modify or vecale any submatic stay or injunction, appears, and any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including threclasure reports), surveyors' reports, and appraisal lees, title insurance, and leas for the extent permitted by applicable law. Trustor also will pay any court costs, in addition to all other sums provided by law.

Rights of Trustee. Trustee shall have all of the rights and dulies of Lender as set forth in this section.

POWERS AND OBLIGATIONS OF TRUSTEE. The following provisions relating to the powers and obligations of Trustee are part of this Deed of Trust:

Powers of Trustee. 




