BACKGROUND: Community Improvement Designation Funds will be allocated to eleven (11) 2016 High School Graduates, who served on the First District Youth Advisory Council, and are recipients of a First District Scholarship.

1. This scholarship award is designed to reward First District Youth Advisory Council Members (YAC) hard work, assist in their education and improve our community.
 - a. All 12th grade YAC members were able to apply for this scholarship.
2. Eligibility considerations are as follows:
 - a. Graduating seniors, attending community colleges, public colleges or universities, private universities, or eligible trade schools (proof of acceptance required)
 - b. Proof of High School Graduation
 - c. Total number of hours that were contributed to the council
 - d. How many years served as a member on the YAC (up to \$250 per year served)
 - e. Has the YAC member demonstrated any growth
 - f. What sorts of ideas or projects have been contributed to on the council
