BACKGROUND:

Summary (continued)

In order to maintain an operational public safety radio and microwave system, the maintenance and repairs needed are critical at the time of each service request. Due to unexpected repairs, including the need for temporary generators to power the sites during such repairs, and the increases to prevailing wage labor rates, the current contract amount needs to be increased.

Impact on Citizens and Businesses

The services will maintain PSEC's radio services to residents of Riverside County by improving the quality of its communication network by keeping generators in working order to power the PSEC radio and microwave sites.
