**BACKGROUND:** Community Designation funds will be given to the following organizations:

1. Quail Valley Volunteer Fire Department – annual support will be used for community programs and services that will provide to the lower income constituents of the Fifth District with opportunities and resources.
2. Quail Valley Environmental Coalition – support funding will be used to assist in the development project of “Neighbors are helping Neighbors” for the dis-advantaged community of Quail Valley.
3. Calicinto Ranch, Inc. – funding support will be used for young children ranging from ages 7-11 as camp scholarships. These children have been placed as part of the incarceration prevention program for prisoner’s children.
4. Enhance the Gift Ministries – annual support will be used for programs and operations for children ages 4 and up to increase their learning ability, skills, talents and GIFTS in a Visual and Performing Arts camp through theatrical, visual and performing arts.
5. Serve One, Inc. – annual support will be used to assist in providing services and meals to the Veterans and homelessness population within the Fifth District by utilizing self-contained, community and emergency services directly to them. The fundamental needs of wholesome foods, personal hygiene and clean clothing through mobile self-contained community and emergency services will restore the dignity and self-respect they seek during pivotal holiday seasons.
