#### **BACKGROUND:**

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, The Tax Collector conducted the April 29, 2014 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 20, 2014. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 16, 2014, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest, (continued on page two)

#### **RECOMMENDED MOTION:**

Authorize and direct the Auditor-Controller to issue a warrant to Priority Collections, Inc. in the amount of \$34,299.04, no sooner than ninety days from the date of this order, unless an appeal has been filed in Superior Court, pursuant to the California Revenue and Taxation Code Section 4675.

#### BACKGROUND: Summary (continued)

The Treasurer-Tax Collector has received three claims for excess proceeds:

- 1. Claim from Priority Collections, Inc. based on an Abstract of Judgment recorded October 1, 2010 as Instrument No. 2010-0472489.
- 2. Claim from Tri-State Land Surveyors and Civil Engineers, Inc. based on a Claim of Lien recorded October 24, 2007 as Instrument No. 2007-0653611 and Release of Mechanic's Lien recorded April 3, 2009 as Instrument No. 2009-0163604.
- 3. Claim from Rio Vista Village Associates, LLC based on a Grant Deed recorded June 14, 2005 as Instrument No. 2005-0470938.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Priority Collections, Inc. be awarded excess proceeds in the amount of \$34,299.04. The claim from Tri-State Land Surveyors and Civil Engineers, Inc. be denied since the lien filed was released with Instrument No. 2009-0163604, recorded April 3, 2009. Since the amount claimed by Priority Collections, Inc. exceeds the amount of excess proceeds available, there are no funds available for consideration for the claim from Rio Vista Village Associates, LLC. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

#### Impact on Citizens and Businesses

Excess proceeds are being released to a lien holder of the property.
