Accomplishments for 2015/16

- July 19-23, 2015, Commissioner Martin attended the National Association of Commissions for Women conference in Indianapolis, Indiana.
- July 29, 2015, The annual planning meeting was held to discuss future topics and goals for the new fiscal year. Meeting dates and conference participated were approved.
- Commissioners Then, McGensy, and Spiegel participated in the planning for the Women's Leadership Program Annual Conference set for September 24, 2015. And on September 24, 2015 the Commission participated in the Women's Leadership Conference held in Riverside, California.
- November 1, 2015, Lenore DeJesus joined the Commission for Women.
- January 28, 2016, Yolanda Carrillo joined the Commission for Women, making it a full commission.
- Chair McGensy, Commissioners Then, Spiegel, Magee, and Fuller attended the State of the County presentation on April 6, 2016.
- Women of the Year May 17, 2016: Five amazing women were honored for working to bring about social and economic change, promote women's equality, serve as an outstanding role model to women and girls, work on behalf of women's issues or provide outstanding performance within a profession to further advocate for women's rights and improve the status of women in Riverside County. Each woman selflessly dedicates her time to improving our County. Honorees were Michelle Paradise, Tracy Mauser, Kelly Bell, Sharron Stroud, and Meghan Kennedy.
- Young Lady of the Year May 17, 2016: For the third time, the Commission honored young ladies, representing each of the five districts, who serve as role models to girls and worked to improve the status of girls in the County. Honorees were Paola Aguiree, Jada Claiborne, Avika Patel, Sophia Felix, and Gabriella Bulacan.
- May 26, 2016, Fonda McGensy accepted the nomination of Chair and Sonja Martin accepted the nomination of Vice Chair. Both were re-elected to serve a second term. Sonja Martin submitted her resignation dated June 23, 2016 and Gina Magee accepted the nomination as Vice Chair.
- Commissioners Fuller, Spiegel, and Chair McGensy attending the Western Riverside Council of Governments (WRCOG) General Assembly Business Session on June 23, 2016.
- Parliamentary Practice to include the Brown Act and Bylaws were reviewed and discussed. It was determined that the Bylaws were in need of a revision to act in accordance to County Policy A-21. A visit from Anita Willis, Assistant County Counsel, educated the Commission on County Policy A-21.

- January 28, 2016, Anita Willis, Assistant County Counsel for Riverside County, addressed Commission Bylaws, Brown Act, and County Policy A-21.
- March 24, 2016, Donyielle Holley, Department of Social Services, gave a presentation on homeless in the County of Riverside.
- May 26, 2016, Nancy Aguirre, Riverside County Anti-Human Trafficking Task Force, Riverside County Sheriff's, addressed the Commission on human trafficking and how it is being conducted in Riverside County and what is being done to address the needs of the victims.
