BACKGROUND:

Summary

The Edward Dean Museum of Decorative Arts located in Cherry Valley was conveyed and transferred by way of gift to the County of Riverside in 1964. The Edward Dean Museum, located at 9401 Oak Glen Road in Cherry Valley houses approximately 2,000 rare books and periodicals. Staff recommends that the Board of Supervisors approve the establishment of the Edward Dean Museum Rare Book Collection as a reference library within the Riverside County Library System (RCLS), adding its inventory to the RCLS Catalogue.

Pursuant to Education Code 19160, the County Free Library is under the general supervision of the Board of Supervisors which may make general rules and regulations regarding the policy of the County Free Library, establishing branches and stations throughout the county, and determine employee needs.

RCLS will be responsible for the maintenance and preservation of the Edward Dean Museum Rare Book Collection Reference Library and will be included in the RCLS/Inland Library Network database.
