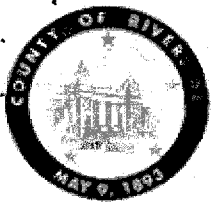

On December 16, 2009, the Registrar of Voters completed a manual tally of the precincts in the December 15, 2009 Valley Health System Special Election in accordance with Elections Code §15360.
