SUBJECT: Authorization to Reissue County Stale-Dated Warrants #2010-2

RECOMMENDED MOTION:

Authorize the reissuance of County Stale-Dated Warrants pursuant to Government Code Section 29802.

BACKGROUND:

Governmental Code 29802 requires a warrant to become void (stale-dated) if it has not been presented for payment to the County Treasurer within six months after the issuance date. Anytime within two years from the date on which the original warrant become void, the payee or assignee of any warrant may request for the warrant to be re-issued. Pursuant to Board Resolution 82-278 (amended Board Agenda 3.5 8/6/1996), the Board of Supervisors approval is needed for amounts \$10,000 and greater. In addition, any warrant that is older than the two-year period requires Board approval. Attachment "A" represents the re-issuance of stale-dated warrants that require the Board of Supervisor's approval. The total amount to be reissued is \$100,521 from the Stale Dated fund.
