SUBJECT: Substantial Amendment to the 2009-2010 One-Year Action Plan

RECOMMENDED MOTION: That the Board of Supervisors amend the County of Riverside 2009-2010 One-Year Action Plan of the 2009-2014 Five-Year Consolidated Plan to include one new HOME Investment Partnerships Act (HOME) project as described in Attachment "A."

BACKGROUND: The United States Department of Housing and Urban Development (HUD) requires that all substantial amendments to the Five-Year Consolidated Plan and the One-Year Action Plan be approved by the Board of Supervisors. All new activities added to the One-Year Action Plan, as well as a significant increase in funding to an existing project or changes to the scope or nature of an existing project, will be considered substantial amendments. Pursuant to 24 CFR 91.105, the Economic Development Agency published a 30-day public notice notifying the public of the proposed amendment to the County of Riverside 2009-2010 One-Year Action Plan and the 2009-2014 Five-Year Consolidated Plan. Staff recommends approval of the new HOME project as described in Attachment "A."

Funding: **\$968,000**

Project Description:

Monte Vista II Family Housing, LLC, a California Limited Liability Partnership (the "Applicant"), whose sole general partner is Affirmed Housing Group, a California Corporation, is proposing to use \$968,000 in HOME funds for the development and construction of a 36 unit multifamily affordable housing complex for qualified low income households families in the City of Murrieta, in the County of Riverside. The Project is located North of Juniper Street, South of Kalmia Street, East of Jefferson Avenue, and West of Madison Avenue.

The proposed project will consist of 14 one-bedroom units, 16 two-bedroom units, and 14 three-bedroom affordable housing units. The one-bedroom units are approximately 650 square-feet, the two-bedroom units are approximately 750 square-feet, and the three-bedroom units are approximately 1,050 square-feet. The total cost of development is estimated to be \$10,576,883.
