

RECOMMENDED MOTION: Move that:

The substandard structure (brick and wood structure built around an unpermitted (1)mobilehome) on the real property located at 28838 Marguerita Road, Lake Elsinore, Riverside County, California, APN 347-210-059 be declared a public nuisance and a violation of Riverside County Ordinance No. 457 which does not permit substandard structures on the property.

Henry F. Scott and Shirley Scott, owners of the subject real property, be directed to abate (2)the substandard structure on the property by rehabilitating, removing and/or demolishing the same from the real property, including the removal and disposal of all structural debris and materials, within ninety (90) days.

- (3) The owners be ordered to ascertain the existence or non-existence of asbestos containing materials in said structure by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- (4) The accumulation of rubbish on the real property located at 28838 Marguerita Road, Lake Elsinore, be declared a public nuisance and a violation of Riverside County Ordinance No. 541 which does not permit the accumulation of rubbish on the property.
- (5) Henry F. Scott and Shirley Scott, the owners of the subject property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days.
- (6) If the owners of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owners, receipt of a Court Order authorizing entry onto the real property, or other authorization as provided by law, shall abate the substandard structure and the accumulation of rubbish by removing and disposing of the same from the real property
- (7) The reasonable cost of the abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Ordinance No. 725.
- (8) County Counsel be directed to prepare the necessary Findings of Fact and Conclusions of Law that the substandard structure on the real property and the accumulation of rubbish are declared to be in violation of Riverside County Ordinance Nos. 457 and 541 and constitute a public nuisance. Further, County Counsel shall prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

- 1. An initial inspection was made of the subject real property by the Code Enforcement Officer on March 24, 2009.
- 2. The inspection revealed a substandard structure (brick and wood structure built around an unpermitted mobilehome) on the subject real property in violation of Riverside County Ordinance No. 457. The substandard conditions of the structure included, but were not limited to the following: hazardous wiring, members of ceilings, roofs, ceiling and roof supports or other horizontal members which sag, split or buckle due to defective material or deterioration, dampness of habitable rooms; general dilapidation or improper maintenance; extensive fire damage. The inspection also revealed

the accumulation of rubbish (approximately 2,140 square feet) on the subject property in violation of Riverside County Ordinance No. 541. The accumulation of rubbish consisted of, but was not limited to the following materials: household trash and debris, plastics, cardboard, electronics, discarded furniture, discarded dog house, scrap wood, Styrofoam, baskets, scrap metal, vehicle parts, carpet, blankets, tarps, a tent, green waste, pallets, a discarded truck camper, tires and a tool box.

- 3. Subsequent inspections of the above-described real property on August 4, 2009, September 29, 2009 and December 28, 2009, revealed that the property continues to be in violation of Riverside County Ordinance Nos. 457 and 541.
- 4. Staff and the Code Enforcement Department have complied with the requirements set forth in the appropriate laws of this jurisdiction pertaining to the Administrative Abatement Proceedings for substandard structure and accumulation of rubbish.

I, Jacob Dietrich, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true and if called as a witness, I could and would competently testify under oath:

- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On March 24, 2009, I conducted an initial inspection of the real property known as 28838 Marguerita Road, Lake Elsinore, within the unincorporated area of Riverside County, California, which is further described as Assessor's Parcel Number 347-210-059 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the approximate location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- 3. A review of County records and documents indicate that THE PROPERTY was owned by Henry F. Scott and Shirley Scott (hereinafter referred to as "OWNERS") at the time of the inspection referenced in paragraph number 2 above. Certified copies of the County Equalized Assessment Roll for the year 2009-2010 and County Geographic Information System ("GIS") report are attached hereto as Exhibit "B" and incorporated herein by reference. THE PROPERTY is located within the R-A (Residential Agricultural) zone classification.
- 4. Based on the Lot Book Report from RZ Title Service dated April 21, 2009 and September 18, 2009, it is determined that an additional party potentially holds a legal interest in THE PROPERTY, to wit: San Bernardino County District Attorney Child Support Division (hereinafter

27 28 collectively referred to as "INTERESTED PARTY"). True and correct copies of the Lot Book Reports are attached hereto as Exhibit "C" and incorporated herein by this reference.

- On March 24, 2009, I conducted an initial inspection of THE PROPERTY on which I observed a brick and wood structure built around an unpermitted mobilehome in a state of general dilapidation. THE PROPERTY was enclosed by a chain-link fence, which was open and accessible and no signs were posted to restrict access. I observed the following conditions which cause the structure to be substandard and THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance 457, as codified in Riverside County Code Title 15:
 - Hazardous wiring: Electrical wires are exposed. 1)
 - Members of ceiling, roofs, ceiling and roof supports or other horizontal members 2) which sag, split, or buckle due to defective material or deterioration: weathered wood with uncovered roofing material.
 - Dampness of habitable rooms: The home is open and exposed to the elements. 3)
 - 4) General dilapidation or improper maintenance.
 - 5) Extensive fire damage: The mobilehome has been placed inside a burnt out structure.
- During the initial inspection on March 24, 2009, I also observed large amounts of accumulated rubbish on THE PROPERTY including, but not limited to, household trash and debris, plastics, cardboard, electronics, discarded furniture, a discarded dog house, scrap wood, Styrofoam, baskets, scrap metal, vehicle parts, carpet, blankets, tarps, a tent, green waste, pallets, a discarded truck camper, tires and a tool box. The total area of the accumulated rubbish was approximately two thousand one hundred forty (2,140) square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of Riverside County Ordinance No. 541, as codified in Riverside County Code Chapter 8.
- A site plan and photographs reflecting the substandard condition of the structure and 7. the accumulated rubbish on THE PROPERTY are attached hereto as Exhibit "D" and incorporated herein by reference.
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- On March 24, 2009, I posted a Notice of Defects, a Notice of Violations (RCC 9. 15.16.020 Substandard Structure and RCC 8.120 Accumulation of Rubbish), a "Danger Do Not

Enter" sign, and a "Do Not Dump" sign on THE PROPERTY.

- 10. On May 11, 2009, a Notice of Noncompliance for the substandard structure and accumulated rubbish was recorded against THE PROPERTY as instrument number 2009-0235966. A true and correct copy of the recorded Notice of Noncompliance is attached hereto and incorporated by reference as Exhibit "F".
- 11. On April 20, 2009 and June 1, 2009, the Notices of Violations (RCC 15.16.020 Substandard Structure and RCC 8.120 Accumulation of Rubbish) were mailed via certified mail to OWNERS and to INTERESTED PARTY on the service list.
- 12. On August 4, 2009 and September 29, 2009, I drove to THE PROPERTY to conduct follow up inspections. The conditions on THE PROPERTY on August 4, 2009 remained the same as my previous inspection. The September 29, 2009 inspection revealed a reduction in some areas of rubbish and a new area of rubbish was estimated to be approximately 150 square feet. Accumulated rubbish remained on THE PROPERTY, the structure remained in a general state of dilapidation, and THE PROPERTY continued to constitute a nuisance to the community.
- 13. I am informed and believe, and based upon said information and belief, allege that OWNERS do not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 14. Based upon my experience, knowledge and visual observations, it is my determination that the substandard structure on THE PROPERTY creates an extreme health, safety, fire and structural hazard to the neighbors and general public and constitutes a public nuisance in violation of the provisions set forth in Riverside County Ordinance Nos. 457 and 541.
- Abate Public Nuisance" providing notification of the Board of Supervisors hearing scheduled for January 12, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNERS and INTERESTED PARTY by certified mail, return receipt requested and on December 28, 2009 was posted on THE PROPERTY. True and correct copies of the notice, return receipt cards, together with the proof of service and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.



- 16. A follow-up inspection on December 28, 2009 revealed that THE PROPERTY remains in violation.
- 17. Significant rehabilitation, removal and/or demolition of the substandard structure and removal and disposal of all structural materials, rubbish and debris are required to abate the public nuisance and bring THE PROPERTY into compliance with Riverside County Ordinance Number 457 (RCC Title 15), the Health and Safety, Uniform Housing, Administrative and Abatement of Dangerous Buildings Codes. In addition, the removal and disposal of all rubbish on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 541.
 - 18. Accordingly, the following findings and conclusions are recommended:
- (a) The structure be condemned as a substandard building, public and attractive nuisance;
- (b) The OWNERS, or whoever has possession or control of THE PROPERTY, be required to rehabilitate or demolish said structure, including the removal and disposal of all structural debris and materials, on THE PROPERTY in strict accordance with the provisions of Riverside County Ordinance No. 457 (RCC Title 15);
- ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the Riverside County Health Department, Division of Special Services; and, prior to the abatement ordered in subsection (b) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines by South Coast Air Quality Management District ("SCAQMD") pursuant to SCAQMD Rule NO. 1403;
- (d) If the substandard structure is not razed, removed and disposed of, or reconstructed in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457 (RCC Title 15), within ninety (90) days after the posting and mailing of the Board's Order and Findings, the substandard structure and contents therein shall be


