BACKGROUND:

The District was granted the surplus land adjacent to our Sunnymead MDP Perris Basin by the County of Riverside when Perris Boulevard was relocated in 1992. This property is referred to as APN 475-060-022 and RCFC Parcel No. 4204-502. The District uses a portion of this property for a staging area when cleaning the basin. The City of Moreno Valley is currently widening the Perris Boulevard and requires a small portion of this parcel for a corner cut. The easement consists of approximately 195 square feet of land. There are no costs to the District associated with this conveyance.

BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Supervisors of the Riverside County Flood Control and Water Conservation District in regular session assembled on January 12, 2010, notice is hereby given, pursuant to California Water Code – Appendix, Chapter 48, Section 48-9, Paragraph 5, that it intends convey an easement interest in a portion of the District's Parcel No. 4204-502 by conveying at or after 1:30 p.m. on February 9, 2010 to the City of Moreno Valley, an easement for street and utility purposes in certain real property in the city of Moreno Valley, County of Riverside, State of California, a portion of Assessor's Parcel Number 475-060-022, being approximately 195 square feet, as described in Exhibit "A" and shown on Exhibit "B", attached hereto and made a part hereof.

BE IT FURTHER RESOLVED AND DETERMINED that the interest to be conveyed is not required for the District's operation and maintenance of Sunnymead MDP Perris Basin and is required for widening of Perris Boulevard within the city of Moreno Valley

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors is directed to give notice hereof as provided in Section 6061 of the Government Code.

COMMENCING AT THE SOUTHEAST CORNER OF SAID PARCEL AS SHOWN IN INSTRUMENT NO. 306494 OF OFFICIAL RECORDS OF SAID COUNTY, SAID POINT BEING ON THE WESTERLY RIGHT-OF-WAY LINE OF PERRIS BOULEVARD (60 FOOT WIDTH);

THENCE ALONG THE SOUTHERLY LINE OF SAID PARCEL, NORTH 89°56'57" WEST, A DISTANCE OF 10.55 FEET (NORTH 89°57'00" WEST, A DISTANCE OF 10.58 FEET PER SAID INSTRUMENT) TO A POINT ON THE WESTERLY LINE OF SAID PARCEL AND THE EASTERLY RIGHT-OF-WAY LINE OF PERRIS BOULEVARD (110 FOOT WIDTH AS DESCRIBED IN INSTRUMENT NO. 306494 RECORDED AUGUST 18, 1992 OFFICIAL RECORDS OF SAID COUNTY), BEING A POINT ON A 2055.00 FOOT RADIUS CURVE CONCAVE WESTERLY, A RADIAL LINE TO SAID POINT BEARS NORTH 69°56'54" EAST;

THENCE ALONG SAID WESTERLY LINE OF SAID PARCEL AND SAID EASTERLY RIGHT-OF-WAY LINE, ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 03°31'24", AN ARC DISTANCE OF 126.37 FEET TO THE **TRUE POINT OF BEGINNING**, A RADIAL LINE TO SAID POINT BEARS NORTH 66°25'30" EAST;

THENCE CONTINUING ALONG SAID WESTERLY LINE OF SAID PARCEL AND SAID EASTERLY RIGHT-OF-WAY LINE, ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 00°34'01", AN ARC DISTANCE OF 20.33 FEET TO THE NORTHWEST CORNER OF SAID PARCEL;

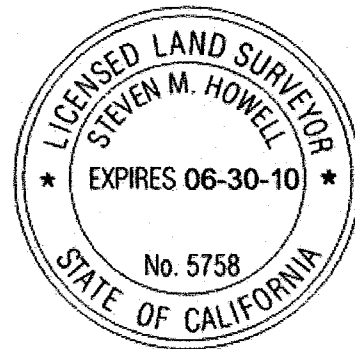
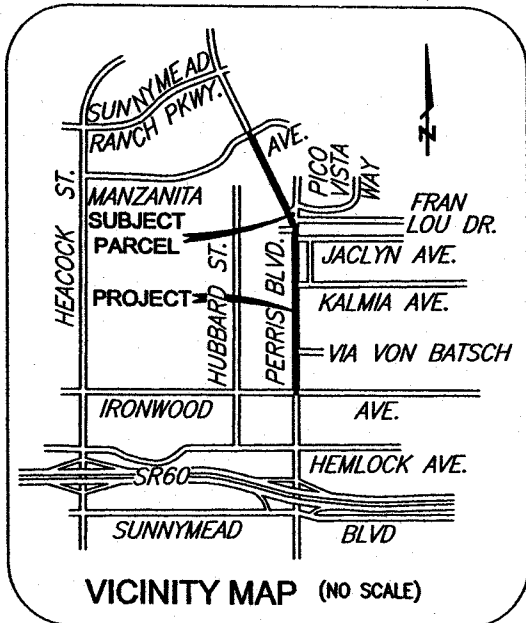
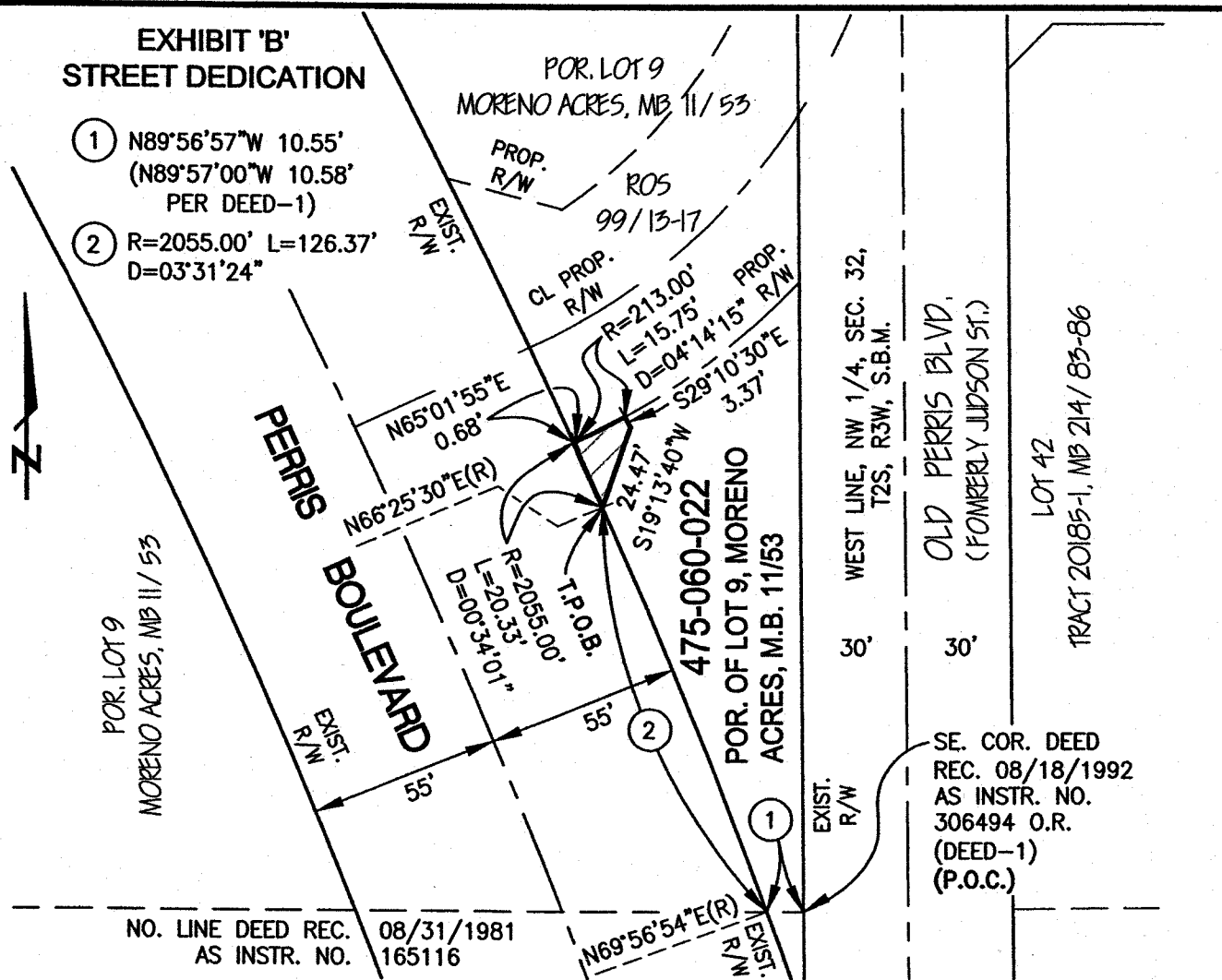


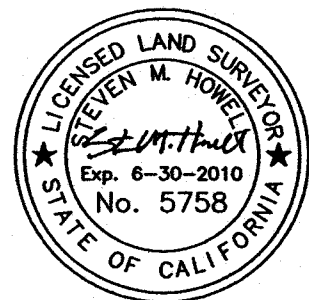
EXHIBIT 'B' STREET DEDICATION
