

**BACKGROUND/APPOINTEE INFORMATION:**

On June 9, 2009 the Board of Supervisors amended the membership section (Section 5, subsection B.) of Ordinance 784 to reflect the appointment of six Commissioners and six Alternate Commissioners. Each member of the Board of Supervisors is to appoint one Commissioner and one alternate with the sixth being an At-Large appointment by the entire Board. These appointments are in addition to those of a member of the Board of Supervisors, the County Health Officer, and an individual responsible for the management of one of several enumerated County functions. The Ordinance specifies the qualifications for appointment, which includes a representative of a Local Child Care Resource or Referral Agency, or Local Child Care Coordinating Group in Riverside County.

Ms. Baskett is the Director of the Children Services Unit with the Riverside County Office of Education. Ms. Baskett also previously worked at First 5 Riverside from 2001-2007 as the Administrator of Early Care and Education programs. Ms. Baskett's experience with child care and early care needs makes her a strong candidate for the Riverside County Children and Families Commission.
