Each member of the Board of Supervisors is to appoint one Commissioner and one alternate with the sixth being an At-Large appointment by the entire Board. These appointments are in addition to those of a member of the Board of Supervisors, the County Health Officer, and an individual responsible for the management of one of several enumerated County functions. The Alternate Commissioners will also serve as Advisory Committee members, in compliance with Proposition 10 statutes.

The Ordinance specifies the qualifications for appointment, which includes a representative of a local medical, pediatric, or obstetric associations or societies. Dr. Touraj Shafai is a pediatrician who has been in private practice in Riverside since 1973. Dr. Shafai previously served as Chief of the Department of Pediatrics for Riverside General Hospital. In addition, Dr. Shafai is a Member of the Board of the American Academy of Pediatrics and Chairman of the Breastfeeding Committee. He has also served on the First 5 Advisory Committee since 2000. Dr. Shafai is extremely well respected and his wealth of experience and commitment will be a tremendous asset to the Riverside County Children and Families Commission. Dr. Shafai will serve as an Alternate to Commissioner Judith Cox.
