RECOMMENDED MOTION: That the Board of Supervisors:

1. Adopt Resolution No. 2010-030 to establish the date, time, and place of a Joint Public Hearing with the Redevelopment Agency Board of Directors to consider Amendment No. 2 to the I-215 Corridor Redevelopment Project Area and the associated Environmental Impact Report.

BACKGROUND: Pursuant to Health and Safety Code Section 33355 the Board of Supervisors and the Redevelopment Agency for the County of Riverside, upon the consent of both, may hold a Joint Public Hearing on Amendment No. 2 to the I-215 Corridor Redevelopment Project Area ("Plan Amendment") to consider adoption of the amendment. Resolution No. 2010-030 establishes a date, time and place for a joint public hearing that will allow affected property owners, residents, businesses, and affected taxing agencies to comment on the Plan Amendment and the associated Environmental Impact Report.
