BACKGROUND: On February 24, 2009 and September 1, 2009 (3.44 and 3.113), the Board approved acceptance of two installments of the 2009 HIDTA grant award from the U.S. Office of National Drug Control Policy (ONDCP) amounting to \$1,712,249.

The Sheriff's Department is now recommending that the Board approve acceptance of a 2009 HIDTA grant augmentation of \$50,000, bringing the total grant award to \$1,762,249. The grant award period is from January 1, 2009 through December 31, 2010. County Counsel has approved the award documents as to form.
