Hydraulics Study requested by Coachella Valley Water District (CVWD) and to prepare the legal and plats for the right of way acquisition needed for the widening on Miles Avenue and Clinton Street.

Due to the timeframe necessary to acquire the needed property for construction and to significantly reduce construction cost and accelerate construction of the project, the project was separated into three phases in order to get some improvements on the ground quickly.

Phase I widened Miles Avenue to four lanes and replaced an existing low water crossing at the Whitewater River with a bridge. Phase 2A widened Miles Avenue between Madison Street and Clinton Street to four lanes and constructed curb, gutter, sidewalk and storm drain improvements within the existing right of way. The construction of both of these phases has been completed.

Phase 2B will widen Clinton Street between Miles Avenue and Fred Waring Drive to four lanes and construct curb, gutter, sidewalk, and storm drain improvements. These improvements will commence in Summer 2010.

This Amendment No. 2 is being processed to provide contract changes to the design and the bid and construction support work that is necessary to complete the project. A detailed description of the additional services and the budget for each are included in Attachment "A" and "B" of the amendment. The primary factors included in this contract amendment are:

- Separating the project into three phases which required revisions to the street improvement plans, signing and striping plans, signal plans, and the engineer's estimate.
 In addition, three separate special provision packages will be required.
- At the request of the City of Indio, the storm drain system was extended approximately 2300 feet on Miles Ave to pick up nuisance water and smaller rain events. In addition, the City of Indio requested that the storm drain line be upsized and the invert slopes be modified to accommodate future connections on Clinton Street. Also, to avoid construction conflicts with an existing sewer line, the Clinton Street storm drain line was redesigned and relocated closer to the westerly curb.
- During the design of Phase 2A, it was determined that the project would be in conflict with the Boe Del Heights Mutual Water Company waterline. Due to a hardship request from the Boe Del Heights Mutual Water Company, water improvement plans were prepared on behalf of the Boe Del Heights Mutual Water Company.
- Provide utility potholing and a utility exhibit for the underground utility lines that will be crossed by storm drain lines along both Miles Avenue and Clinton Avenue.
- Preparation of a bridge railing study and revisions to the bridge railing plans to provide additional light blocking characteristics.

- 4. Except to the extent specifically modified or amended hereunder, all of the terms, covenants, and conditions of the Agreement as approved on July 30, 2001, shall remain in full force and effect between the parties hereto.

ATTACHMENT A - SCOPE OF SERVICES

A. Revisions to the Street Improvement Plans to Accommodate 3 Phases

To accelerate the construction of the project, the project was separated into three phases. Phase 1 includes the widening of Miles Avenue and replacing the low water crossing at the Whitewater River with a bridge. Phase 2A will reconstruct and widen Miles Avenue from Madison Street to Clinton Street. Phase 2B will reconstruct and widen Clinton Street from Miles Avenue to Fred Waring Drive. Modifications to the existing plans are required to separate the project into three phases. The phasing of the project will require revisions to the street improvement and signing/striping plans. This additional scope of work requires:

- Staff time for revising of the Street Improvement Plans.
- Staff time to coordinate with the City of Indio and County for the acceptance of the plans.
- Staff time to coordination with utility companies on phasing the utility relocation plans.
- Staff time to address any comments from the City of Indio and County.

B. Preparation of Specifications

Separating the project into 3 phases will require the development and review of two additional project specifications. It is anticipated that the County will develop the front end documents and County's general special provisions for the overall bid package with the Consultant reviewing the County's general special provisions and providing additional specifications as necessary. This additional scope of work requires:

Staff time to review and prepare special provisions.

C. Preparation for Engineer's Construction Cost Estimates and Quantities

Separating the project into 3 phases will require calculations of construction quantities and development of an estimate of probable construction costs for each project phase. Deliverables will include providing estimated construction quantities and development of probable construction cost estimates for each phase of the project. This additional scope of work requires:

Staff time to calculate quantities and prepare Engineer's Construction Cost Estimates.

D. Preparation of Storm Drain Plans for Miles Avenue

The original agreement included the preparation of the design of a storm drain system along Clinton Street.

After the completion of the design of the storm drain system, the City of Indio requested that the storm drain system to be extended approximately 2,300 feet on Miles Avenue to pick up nuisance water and smaller rain events. This additional scope of work requires:

- Staff time for the preparation of plan sheets
- Staff time to coordinate with the City of Indio and County for the acceptance of the plans

E. Revisions to the Clinton Street Storm Drain Plans

Following the completion of the hydrology study, the City of Indio requested that the Clinton Street storm drain line be upsized and revision be made to the invert slope to accommodate future connections to the line south of the project limits. In addition, to reduce the potential impacts with the sewer mainline during the construction of the storm drain, approximately 2700 lineal feet of the storm drain line will need to be shifted to the west side of Clinton Street, closer to the curb and gutter. As a result of this relocation, additional coordination will be necessary with utility companies on resolution of facility impacts. The vertical and horizontal realignment of the storm drain line will also require the redesign of 17 lateral connections. This additional scope of work requires:

- Staff time for revising of the storm drain line.
- Staff time to coordinate with the City of Indio and County for the acceptance of the plans.

F. Preparation of Horizontal Control Plan Sheets for Both Miles Avenue and Clinton Street

To assist the County field personnel during construction, separate horizontal control plan sheets for Miles Avenue (Phase 2A) and Clinton Street (Phase 2B) will be prepared. In addition, modification to the Street Improvement Plan sheets will be required to remove all horizontal control information that is referenced on the plans. This additional scope of work requires:

- Staff time to prepare the Horizontal Control Plan sheets.
- Staff time to modify the Street Improvement plans.

G. Prepare Removal and Utility Plan Sheet for Miles Avenue and Clinton Street

Prepare separate Removal and Utility Plan sheets for Miles Avenue (Phase 2A) and Clinton Street (Phase 2B). The Removal and Utility Plan will identify obstacles and utilities that are in conflict with the construction of these projects. In addition, modification to the Street Improvement Plan sheets will be required to remove all Removal and Utility relocation information that are referenced on the plans. This additional scope work requires:

Additional staff time to prepare the Removal and Utility Plan sheets.

H. Preparation of Driveway Improvement Plan Sheets

Prepare Driveway Improvement Plan sheets showing the proposed improvements to all of the driveways within the project limits. Depending on the feasibility of the property, a circular, hammerhead or a straight driveway configuration will be designed for the properties fronting Miles Avenue and Clinton Street. The Driveway Improvement Plan sheet will later be used for negotiation with the property owners that will be affected by the widening of Miles Avenue and Clinton Street. The Consultant will also be required to verify the necessary construction limits that will be necessary to provide the construction of either the circular or hammerhead type driveway. Deliverables will consist of a plan view sheet labeling the driveway approach and driveway treatment for all replaced driveways along both Miles Avenue and Clinton Street. This additional scope of work requires:

- Staff time to Prepare the Driveway Improvement Plan Sheets.
- Staff time to coordinate with the City of Indio and County for the acceptance of the plan sheet.
- Staff time to address any comments from the City of Indio and County.

I. CVWD Encroachment Permit Application for Roadway Improvements and Utility Encroachment

Since the project involves work within the Coachella Canal (All American Canal) easement, the Coachella Valley Water District (CVWD) requested that the County obtain a license agreement with the Bureau of Land Management for construction activities and permanent construction within the canal easement area. The license agreement will include preparation of a Phase 1 Environmental Site Assessment for the area of

potential disturbance within the canal easement and a composite utility plan for each utility crossing the canal. In addition, CVWD requested that the project include all existing and relocated overhead utilities crossings the canal in the County's license package submittal. This additional scope of work requires:

Staff time to prepare the Phase 1 Site Assessment, permit package for Riverside County, IID, Verizon and Time Warner for license agreements, and preparation of composite utility exhibit for the utility facilities crossing the canal as well as revision to the street improvement plans to include information required by CVWD to process the permit application.

J. Prepare Retaining Wall Plans

Prepare analysis and designs for retaining walls along the Lyndon B. Johnson Elementary School located on Clinton Street, at the gas station located at the southwest corner of Clinton Street and Miles Avenue and the replacement of the existing retaining wall located along Miles Avenue just east of Swingle Street. This additional scope of work will require:

Staff time to prepare retaining wall plan sheets and analysis.

K. Prepare Water Improvement Plans

Prepare Water Improvement Plans for the replacement of a private water system, owned by Boe Del Heights Mutual Water Company that is in conflict with the proposed street improvements. The Water Improvement Plan sheets will include the design of a 4" PVC line that will replace the existing water main line, connections at each end and water services to each of the homes serviced off of Miles Avenue. This task will also include coordination with Boe Del Heights Mutual Water Company and the Indio Water Authority on the design parameters with this line. This additional scope of work requires:

- Staff time to prepare water line plans for Boe Del Heights Mutual Water Company.
- Staff time to coordinate with Indio Water Authority during the design of the water line for Boe Del Heights
 Mutual Water Company.
- Staff time to address any comments due to the design of the water line.

L. Prepare Utility Potholing Exhibit

Under Amendment No. 1, the Consultant was to provide utility potholing at 14 locations. With the inclusion of the private water system and the additional storm drain line along Miles Avenue, the number of pothole locations increased to a total of 42 potholes. In addition, the Consultant will prepare an exhibit showing survey locations and elevation for the potholes. This additional scope of work requires:

- Staff time to prepare utility pothole cut sheets.
- Staff time needed to add the pothole information to the Utility Plans and to the proposed Storm Drain and
 Water Improvement Plans.
- Staff time to coordinate with the County and City of Indio for the locations where potholes are needed.

M. Revise the Plats and Legal's for the Right of Way Easements and Acquisitions

Under Amendment No. 1, Consultant was to provide 96 Plats and Legal Descriptions for the County's use in the Right of Way acquisition process. Consultant will revise the Plats and Legal Descriptions for the Right of Way Easements and Acquisition to address additional requirements needed for the recordation of the documents. During the design, the corner cut backs located at the street intersection were changed to radial to save on the amount of right of way acquisition needed to widen Miles Avenue and Clinton Street. This change will require the full revision of 20 plats and legal descriptions for right of way acquisition and temporary construction easements. In addition, due to acquisition changes during the design process, 5 additional plats and legal descriptions will require full revisions. Consultant will also need to prepare two additional plats and legal descriptions to acquire CVWD access easements along the northwest and north east quadrants of the Miles Avenue Bridge. This additional scope of work requires:

- Staff time to prepare Plats and Legal Descriptions
- Staff time to coordinate with County survey group to address comments to the Plats and Legal Descriptions.

N. Revise the Signing and Striping Plans Sheets

At the request of the City of Indio, modification to the Signing and Striping Plan will need to be made to

eliminate parking along Miles Avenue and to include a Class II bike lane along both Miles Avenue and Clinton Street. Modification to the striping of roadway and additional signage will be needed to provide for this bike lane and to restrict parking. This additional scope of work requires:

- Staff time to revise the Signing and Striping plan.
- Staff time to coordinate with the City of Indio and County for the acceptance of the plans.

O. Revise Signal Plan Sheets and Prepare a Signal Modification Sheet

Based on the requested changes to accommodate bike lanes and restrict parking on both Miles Avenue and Clinton Street, revisions to the Signal Plans at Madison Street, Swingle, and Clinton Street along Miles Avenue and at Palmyra along Clinton Street will be necessary.

The Signal Plans at the intersection of Madison Street and Miles Avenue will also need to be modified to replace the loop detector with video detection due of the proximity of the bridge structure over the All American Canal.

In addition to accommodate the construction of Phase 2A, the Consultant will be required to prepare a Signal Modification Plan for the intersection of Clinton Street and Miles Avenue. This signal modification plan will replace the loop detectors with video detection. The video detection will make it easier to accommodate construction staging once the project is in construction. This additional scope of work requires:

- Staff time to revise the Signal Plan and Signal Modifications Plans.
- Staff time to coordinate with the City of Indio and County for the acceptance of these plans.

P. Prepare Bridge Railing Study and Revise the Bridge Railing Plans

City requested modifications to the railing system to provide additional light blocking characteristics. Consultant shall provide additional concept and renderings showing both concepts to the metal railing on top of the currently proposed concrete bridge barrier. This metal railing will provide light blocking and shall be a minimum of four feet in height above the finished roadway surface at the curb line. It is anticipated by the Consultant that there will be one round of comments and revisions to the railing concepts. Following approval of the final railing concept, Consultant will provide the necessary details for the construction. Deliverables will
