



BACKGROUND:

Christopher's Clubhouse is a non-profit organization that provides a comprehensive community safety package and addresses the issues of missing children with an educational campaign, parental support programs and child safety projects.

Jordan Outreach Ministries operates the Kids Klub after-school program for children ages 5 through 18. The program provides free transportation to families who are unable to provide it. It targets and serves children from Indio, Coachella, Thermal, Mecca and the outlying unincorporated areas of the community. The program offers a variety of enriching activities, including: Study Klub, sports, computer center activities and learning, arts and crafts, and other age-appropriate activities.

The Sky Valley Community Center serves as the meeting site for the Sky Valley Community Council, the Community Services Agency #104, the Citizens on Patrol, the Sky Valley Home Owners Association, the Hot Springs Community Council, the Emergency Team meetings and drills, the Mobile Library and is the Polling site for elections.

The Valley Partnership's Americorps program provides tutoring services to elementary students in the Coachella Valley Unified School District. The focus is literacy in kindergarten through third grade. The tutors assist students with their reading and English fluency proficiency during classroom instruction and focus on science activities in the after school program.

We would like to use Fourth District Community Improvement funds to assist these organizations in providing services in our communities.
