


PHOTO #2 POSTED 24 HOUR NOTICE








PHOTO # 1 NOTES: View of 25097 Jutland Dr. Hemet Ca. 92544 with violation of excessive outside storage.




PHOTO # 2 NOTES: View of the excessive storage in the rear of the property from an open property behind the residence.




PHOTO # 4 NOTES: View of storage at the rear of the residence with adjacent property fence line.




PHOTO # 6 NOTES: View of storage from adjacent property




PHOTO #13 NOTES: Closer view of gate in fence for access to storage in the rear of the house.




PHOTO # 7 NOTES: View rear of the property with RVS x2 and shedsx3, inoperable vehicles and debris.




PHOTO # 9 NOTES: View of the property from Fairview Ave. it has become a public nuisance.




PHOTO # 11. NOTES: Posting, notice of violation


