
By proclaiming February 2010 to be American Heart Month in the County of Riverside, the Board of Supervisors will support the national and local movement to bring attention to improving women's health.

Recognizing

February as American Heart Month and advocating support for Go Red for Women Day in Riverside County

WHEREAS, Diseases of the heart are the nation's leading cause of death, and stroke is the third leading cause of death; and

WHEREAS, Cardiovascular disease claims the lives of more than 460,000 American women, about one death per minute, each year; and

WHEREAS, Each year, 53 percent of all deaths from cardiovascular disease occur in women, and about 32,800 more women than men die from stroke; and

WHEREAS, The direct and indirect cost of cardiovascular disease and stroke in the United States are nearly \$450 billion; and


WHEREAS, More women die of cardiovascular disease than the next five leading causes of death combined, including all cancers; and

WHEREAS, Go Red for Women Day is the American Heart Association's national call to increase awareness of heart disease, the leading cause of death for women, and to inspire women to take care of their heart health; and

WHEREAS, All women should learn their own personal risk for heart disease, using tools such as the American Heart Association's Go Red for Women Heart Check Up and by talking to their health care providers;

NOW, THEREFORE, LET IT BE RESOLVED, that the Board of Supervisors of the County of Riverside does hereby recognize February 2010 as American Heart Month and February 5, 2010 as Go Red for Women Day; and be it further
