

SUBJECT: Approval of Election Services and Consolidation of Elections

RECOMMENDED MOTION: That the Board approve election services and consolidation of the 37th Senatorial District Special Vacancy Primary Election and the City of Rancho Mirage General Municipal

Election for the April 13, 2010 Consolidated Special Election.

BACKGROUND: California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to consolidate and conduct elections by submitting a resolution requesting these services. The city of Rancho Mirage has complied with this requirement and requests the Registrar of Voters to consolidate their municipal election with the 37th Senatorial District Special Vacancy Primary Election and conduct the election. The department has the resources to consolidate and conduct the City's election. Rancho Mirage will reimburse the department based on associated direct costs.
