BACKGROUND: (Continued)

A wireless system utilized by RCRMC reached end-of-life (EOL) and required the need for a replacement system. RCIT developed a replacement solution that changes out the former "freeseet wireless handset" used by hospital personnel to a new "dect wireless phone."

This replacement utilizes our current telephone network eliminating the need for new infrastructure and a capital expense. The new instrument provides enhanced features and functionality. At the time the wireless solution was developed however, the rate was not yet modified to reflect the cost of the new device.

On February 3, 2009 (M.O. 3.31), the Board of Supervisors approved rates for the Solidus call center system (system software that queues and directs a caller to an appropriate Call Center Agent). As this was a new enhanced service, it was not yet fully understood the various features that could be provided to best suit the department's needs. As RCIT began implementing this call center system for departments, we learned that we could provide many more functions at a reduce cost to the departments. The attached rate sheet reflects the new Solidus features and pricing structure.

Departments can expect significantly reduced costs as a result of the granular options provided with this new Solidus pricing structure. For example, the new "Desktop Agent" service at \$72.23 replaces previous limited service options provided by the "Solidus Gold service," at a price of \$110.74 per month and a "Solidus Platinum service," at the price of \$147.66. A telephone service cost of \$258.40 per month will now be reduced to \$72.23 and provides for added features and services to the department.

RCIT currently utilizes Sharepoint for document management and collaboration services and has been asked by departments to provide this service to meet their business needs. The attached rate reflects the cost of hosting a Sharepoint Site.

As an internal service fund (ISF), RCIT develops a budget and related rates based on current business drivers; county budget reductions, decreased customer needs in specific service areas and requests for new technology. The development and modification to existing rates as noted on the attached rate sheet reflects the changing needs of our departments. RCIT products/services and related rates will continue to change as the needs of departments change and technology changes.

RCIT will continue to seek ways to further refine and reduce costs to help departments address their business needs.
