SUBJECT: Approval of the Amendment to the Agreement between the County of Riverside and the Riverside Police Department


RECOMMENDED MOTION:

BACKGROUND: Riverside County Regional Medical Center is required by the State of California Penal Code Section 13823.9 (b) to provide professional personnel trained in examining sexual assault victims. An agreement was established with the Riverside Police Department to provide sexual assault examination services for their department. This amendment extends the agreement effective July 1, 2009 through June 30, 2010.







**FIRST AMENDMENT
TO THE
PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE
COUNTY OF RIVERSIDE
AND
RIVERSIDE POLICE DEPARTMENT**

That certain Agreement, by and between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and the City of Riverside, hereinafter referred to as CITY, is hereby amended effective July 1, 2009, as follows:

1. Amend the language of Section IV. A. to include the following:

"This Amendment extends the term of the Agreement from July 1, 2009 through June 30, 2010, unless renewed by mutual agreement or terminated as specified below in Section IV. B, or as otherwise provided herein."

All other terms and conditions of this Agreement are to remain in full force and effect.
