SUBJECT: FY 2010-2011 Service Rates for Riverside County Information Technology (RCIT)

RECOMMENDED MOTION: That the Board of Supervisors approve the attached Riverside County Information Technology service rates for FY 2010-2011.

BACKGROUND: RCIT's FY10/11 budget represents an estimated \$3.7 million decrease in information technology service costs to county departments.

As an internal service fund (ISF), RCIT develops a budget based on current business drivers; budget reductions, decreased customer needs in specific service areas and requests for new technology services to meet business needs. **(Continued on Page 2)**

BACKGROUND: (Continued)

Cost savings were achieved in specific areas as a result of staff's work with service providers to negotiate lower service rates, maximize contract savings and collaborate on volume purchases. Additionally, the budget minimizes staff development training, extends equipment replacement schedules, and reduces maintenance/service agreements and staff positions. Although the budget reflects various reductions due to economic trends, it also reflects new business opportunities as departments turn to RCIT to help meet their business needs during these challenging times. RCIT will continue to look for opportunities to reduce costs, achieve operational efficiencies and assist departments with their business needs.

As a result of the Board imposed furloughs for Management/Confidential and SEIU personnel, the \$100 reduction to health coverage and the decrease to the 401(a) plan for Management/Confidential, RCIT will achieve an accumulated \$1.4 million reduction in salaries and benefits by the end of this fiscal year. The attached outlines the rebate to departments resulting from the aforementioned savings and also includes another \$800,000 of undesignated, unrestricted assets that can be distributed to the departments. The reduction to RCIT expenses as a result of the referenced savings above will assist departments in meeting their FY10/11 budget targets. The rebate will be applied to the departments' FY10/11 billings.

In addition to the proposed rebate, the Executive Office supports the RCIT requested designation of \$4.5 million, funded from unrestricted assets, for data center and system upgrades and Information Technology Governance Committee (ITGC) initiatives.

- The Data Center is in need of expansion in order to accommodate new space requirements from County Departments. This level of efforts involves analysis, recommendations and implementation of structural integrity, environmental and redundant power. The estimate to complete this effort is \$1.7 million.
- The ITGC initiative requires staffing to carry out the initiatives and directions of the ITGC. Responsibilities of this staff include conducting analysis, developing business cases as decision making tools for the ITGC, developing and managing the operating budget for ITGC initiatives, managing the assessment contract, assuring the initiatives are implemented in accordance with the ITGC direction. The estimate for this effort is \$3,137,267 over a two year period.
- As a part of both the Data Center expansion and the known ITGC initiatives, an upgrade to the Call Center environment used by RCIT as well as other County Departments is also required. The estimate for this effort is \$510,000.

As further budget savings are achieved and/or adjustments are made to fund balance, RCIT will return to the Executive Office and Board for further designations and/or rebates.
