SUBJECT: Adoption of County Resolution No. 2010-078 Amending and Correcting County Resolution No. 2010-057 Setting the Eastvale Reorganization for Election

RECOMMENDED MOTION: That the Board of Supervisor adopt County Resolution No. 2010-078 (attached) amending and correcting County Resolution No. 2010-057 setting the Eastvale reorganization for election on June 8, 2010.

BACKGROUND: On January 26, 2010, the Board of Supervisors adopted County Resolution No. 2010-057 setting the Eastvale reorganization election for June 8, 2010. The Registrar of Voters called to County Counsel's attention that resolution mistakenly contains a clause that calls for the naming of the city to be placed on the ballot. That is not an action contained in LAFCO Resolution No. 01-10 pertaining to the reorganization, and should not have been included in County Resolution No. 2010-057. County Resolution No. 2010-078 amends and corrects County Resolution No. 2010-057 by removing that clause.

2 RESOLUTION NO. 2010-078

3 RESOLUTION OF THE BOARD OF SUPERVISORS OF  
4 THE COUNTY OF RIVERSIDE AMENDING AND CORRECTING  
5 RESOLUTION NO. 2010-057 SETTING THE CITY OF EASTVALE  
6 REORGANIZATION FOR ELECTION (LAFCO NO. 2008-18-2)

7 WHEREAS, the Local Agency Formation Commission (LAFCO) on January 21, 2010,  
8 approved the City of Eastvale Reorganization (Exhibit "B") to include the incorporation of the City of  
9 Eastvale and detachment from the Riverside County Waste Resources Management District; and

10 WHEREAS, LAFCO requested the Board of Supervisors conduct an election on the  
11 subject reorganization;

12 WHEREAS, the Board of Supervisors of the County of Riverside, State of California, in  
13 regular session assembled on January 26, 2010, ordered that:

14 1. The reorganization shall be subject to confirmation of the voters upon the question  
15 thereof at an election that shall be held on June 8, 2010, within the entire territory described in Exhibit  
16 "A" attached hereto and incorporated herein. The question submitted at such election shall be as follows:

17 "Shall the order adopted on January 21, 2010, by the Local Agency Formation  
18 Commission of Riverside County ordering the incorporation of the territory described in  
19 the order, including detachment from the Riverside County Waste Resources  
20 Management District, subject to the terms and conditions specified in the order  
21 designated as LAFCO No. 2008-18-2 (Resolution No. 01-10) be confirmed?"

22 This order of reorganization shall be confirmed where such question is favored by a  
23 majority of the votes cast within the entire territory within which the election is held.

24 2. At the election called pursuant to paragraph 1 above, provision shall also be made  
25 for the election at large of five members of the City Council, and the question of whether members of the  
26 City Council of the City of Eastvale in the future elections shall be elected by district, from district, or at  
27 large shall be submitted to the voters.

28 3. Further, at the election called pursuant to paragraph 1, provision shall be made for  
presenting to the voters the question of whether the city shall be called Eastvale.

1           4.     The Clerk of the Board shall transmit a certified copy of this Resolution to the  
2 Executive Officer of the Local Agency Formation Commission and the Registrar of Voters."

3           WHEREAS, Paragraph No. 3 above was inadvertently included in the resolution and does  
4 not need to be presented to the voters on the ballot. Now, therefore,

5           BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of  
6 Riverside, State of California, in regular session assembled on February 9, 2010, that:  
7 Resolution 2010-057 is amended and corrected to delete Paragraph No. 3 which reads:

8           "3.     Further, at the election called pursuant to paragraph 1, provision shall be made for  
9 presenting to the voters the question of whether the city shall be called Eastvale."
