My name is Reba Marshall; I live at 18151 Haines Street which is located next door to the project. In the notice to the public hearing they do not put the address of the facility they're talking about; they have the location as northerly of Markham, and southerly of Oleander Ave, Easterly of Brown Street, and Westerly of Haines. Most of the neighbor's here that received this public hearing notice, did not know it was on Haines. I totally object to this facility. Currently, there are about 13-14 people living in the facility. These people have substance abuse issues, the are mentally unstable, one of them also engaged in sexual solicitation, parolees some of which also have anger issues resulting in violence, and panhandling.

As of now, as a homeowner I have experiencing ciphering gas from my vehicle, items stolen from my secured property, loitering on my property; Furthermore the supervision at the facility is very poor, and to my knowledge they have no supervision at all, in the evening. I have also experienced one of the mentally ill persons in my secured

yard. At that time I spoke Mr. Hamid Rafizadeh about the issue, and he informed me that the resident was mentally ill and had not taken his medication in 3 months. I would like to know how would you let a mentally ill person go 3 months without there medication? Mr. Hamid Rafizadeh was afraid to remove the mentally ill resident from my yard and instructed me to call the police, which I did. I talked with Mr. Hamid Rafizadeh and asked him in a civilized way if, he can not control one mentally ill resident, how is he going to be able to control 36 (all of which would not be mentally ill persons)?

I personally do not understand how the City of Perris valley has permitted this facility to be this close to several grammar schools; and two houses from a nursing home. In a separate instance one of the gentlemen in that home exposed himself to one of the neighbor's adolescent daughters. That neighbor no longer resides there, she has moved. Now, how safe are the kids passing to school? We have had a safe neighborhood, here for 35 years until now (meaning the business next door housing those people). Mr. Hamid Rafizadeh had a 32 bed home in downtown Perris Ca, which got burned down, in which a life was lost. He lives in a safe neighborhood, why can't I? So in conclusion, I would like to request that you please consider objecting to this application for public use permit number 892.

PROPOSED DECISION

Administrative Law Judge Greer D. Knopf, State of California, Office of Administrative Hearings, heard this matter in Riverside, California, on June 10, 2009.

Cori A. Dutra, Staff Counsel, represented complainant Jo Frederick, Deputy Director, Community Care Licensing Division, Department of Social Services, State of California.

Hamid Rafizadeh, respondent, appeared and represented himself.

The matter was submitted on June 10, 2009.

FACTUAL FINDINGS

- 1. The accusation dated December 30, 2008, was filed in this matter against respondent Hamid Rafizadeh (respondent) by complainant Jo Frederick (complainant) in her official capacity as Deputy Director, Community Care Licensing Division, Department of Social Services, State of California. Thereafter, complainant filed the first amended accusation dated May 11, 2009. The first amended accusation seeks to revoke respondent's license to operate an adult residential facility, to deny a criminal record exemption, to exclude respondent from employment at, presence in, or contact with any client of any licensed facility, and to revoke respondent's administrator's certificate. Respondent filed a notice of defense dated January 12, 2009, requesting a hearing be held in this matter. The proceeding herein ultimately followed.
- 2. Respondent is licensed by the Department of Social Services, State of California (Department) to operate an adult residential facility. Respondent operated an adult residential facility (the facility) located at 154 E. 2nd Street, Perris, California. The facility was initially licensed on November 29, 2001. As of January 29, 2004, the facility was licensed to care for a total of 42 mentally disabled adults ages 18 to 59 with one non-

ambulatory and 47 ambulatory clients. The facility was also authorized to care for individuals that have the restricted health care condition of insulin-dependent diabetes.

3. Respondent is also certified to be an adult residential facility administrate.

- 3. Respondent is also certified to be an adult residential facility administrator. On July 10, 2001, the Department certified that respondent had successfully completed the Adult Residential Administrator Certification Program and issued a Standard Certificate to respondent as an adult residential facility administrator.
- 4. On October 29, 2007, in the United States District Court, Central District of California, respondent pleaded guilty to and was convicted of a violation of Title 42, United States Code, section 1320, subdivision (a)-7b(B)(1)(A). This conviction was a felony conviction for solicitation and receipt of Medicare kickbacks. The conviction arose out of respondent's arrest when he was operating his licensed facility and acting as the facility administrator in 2001 and 2002. As part of respondent's guilty plea, he admitted to the following facts:

"From approximately late 2001 through 2002, defendant [respondent] solicited and received financial kickbacks for the referral to Dr. David Asher residents of Perris Place, a board and care facility located in Perris, California. Defendant periodically would provide Dr. Asher and people acting on Dr. Asher's behalf with the identities and Medicare numbers of board and care residents. These residents would be used as patients for respiratory treatments. In exchange, Dr. Asher paid defendant financial kickbacks usually in cash. In total, defendant received approximately \$8,500.00 in respiratory treatment referral kickbacks over an approximately 14-month period. At the time, defendant solicited and received the kickbacks, defendant knew that it was unlawful to do so."

- 5. Respondent was sentenced to one year probation and ordered to pay a \$100.00 special assessment and restitution to the victims in the amount of \$8,500.00. The court also ordered respondent to pay an additional fine in the amount of \$5,000.00 and comply with general terms and conditions of probation, including that respondent would not be permitted to be employed by or own or control any board and care facility while on probation. Respondent has completed all terms of his criminal sentence and is no longer on probation.
- 6. There was no evidence presented to establish that the Department ever notified respondent that he needed to obtain a criminal record exemption due to his criminal conviction, but respondent testified at the hearing that he did want to obtain such an exemption. Complainant requests that such an exemption be denied, contending that there is not substantial and convincing evidence to support a reasonable belief that respondent is of such good character as to justify the granting of an exemption.
- 7. Respondent maintains he is deserving of a criminal record exemption and requests that he be allowed to work again as a facility administrator. He asserts that facility administration is the only work he is qualified to do and therefore he should be given another chance. However, respondent did not establish cause for a criminal record exemption. He clearly has not accepted responsibility for his criminal actions. He tried to minimize his own

culpability by saying that he did not recall the details of what happened, such as the name of the physician involved, and that he was only arrested because the physician in question accused respondent. In his testimony, he was very vague about details and blamed his prosecution on the doctor who reported him. Respondent also stated that he only pleaded guilty because he could not afford to pay an attorney to fight the charges. He did not accept any responsibility for his part in this ongoing criminal activity. Respondent expressed remorse only for his own personal predicament, but did not express any remorse for his criminal actions or for the victims of his crime. Respondent should be commended for trying to now move forward after his criminal conviction to put his life back on track. However, respondent committed a serious crime of dishonesty while working as a facility administrator and he failed to present sufficient evidence of rehabilitation. There is not substantial and convincing evidence to support a reasonable belief that respondent is of such good character as to justify the granting of an exemption. Without a criminal record exemption, respondent should be excluded from employment or presence in any licensed facility and should not be allowed to hold a license to operate an adult residential facility or certification as a facility administrator.

LEGAL CONCLUSIONS

- 1. Cause exists to deny respondent an exemption and exclude respondent from employment at any licensed facility pursuant to Health and Safety Code sections 1522 and 1558 and Title 22, California Code of Regulations, sections 80019 and 80019.1 in that respondent has been convicted of the crime of solicitation and receipt of Medicare kickbacks and there is not substantial and convincing evidence to support a reasonable belief that respondent is of such good character as to justify the granting of an exemption, as set forth in Findings 2-7.
- 2. Cause exists to deny respondent an exemption and exclude respondent from employment at, or presence in, any licensed facility pursuant to Health and Safety Code sections 1522, 1550, 1558, and 1562.3 and Title 22, California Code of Regulations, sections 80019, 80019.1, and 85064.4 in that respondent has been convicted of the crime of solicitation and receipt of Medicare kickbacks and should be prohibited from employment in, presence in, and contact with clients of any facility licensed by the Department, and from being a member of the board of directors, executive director, or any officer of a licensee of any facility licensed by the Department for the remainder of respondent's life, as set forth in Findings 2-7.
- 3. Cause exists to discipline respondent's license to operate an adult residential facility pursuant to Health and Safety Code section 1550 in that respondent has been convicted of the crime of solicitation and receipt of Medicare kickbacks for which he has not obtained a criminal record exemption, as set forth in Findings 2-7.
- 4. Cause exists to discipline respondent's certificate as an administrator for adult residential facilities pursuant to Health and Safety Code section 1550 and Title 22, California Code of Regulations, section 85064.4 in that respondent has been convicted of the crime of

solicitation and receipt of Medicare kickbacks for which he has not obtained a criminal record exemption, as set forth in Findings 2-7.

- 3. Respondent Hamid Rafizadeh's license number 336405878 to operate an adult residential facility is hereby revoked.
