SUBJECT: Allocation of Development Impact Fee Funds

RECOMMENDED MOTION:

1. Authorize the use of up to \$60,103.66 of Development Impact Fees from the Upper San Jacinto Valley Area Plan Flood Control Facility Fund (Fund 30538) for costs associated with the San Jacinto River Levee, Stage 4.
2. Direct the Executive Office to transfer up to \$60,103.66 of Development Impact Fees from the Upper San Jacinto Valley Area Plan Flood Control Facility Fund (Fund 30538) to the Flood Control and Water Conservation District as needed, pursuant to contracts and billings received for the San Jacinto River Levee, Stage 4.

BACKGROUND:

The Development Impact Fee (DIF) program, which is governed under Ordinance 659.6, allows for the use of DIF funds for those facilities identified on the Public Facilities Needs List to the Year 2010, in which the San Jacinto River Levee, Stage 4 is included.
