**BACKGROUND:** (Continued)

On November 18, 2008, the Board of Supervisors approved a Job Order Contract with MTM Construction, Inc. and the County of Riverside. A job order was issued pursuant to that contract for supplemental work, additional Megapixel Security Cameras, at the CJB Security Camera Project in the amount of \$8,895.

The project was inspected and found to comply with all contract requirements. This Board action will release to MTM Construction, Inc., the balance of the contract retention funds of \$890.
