Section 1. Section 2. Of Ordinance No. 720 is amended to read

"Pursuant to Penal Code Section 1203.1b(h), when a judgment has been made that a defendant pays a fine, the fine may be paid by installment payments. The Board of Supervisors authorizes a fee of \$75.00 for the processing of installment accounts."

Section 2. Section 3. Of Ordinance No. 720 is amended to read

"Pursuant to Penal Code Section 1203.4(d), the Board of Supervisors authorizes a fee of \$150.00 to be charged to a person requesting a change of plea or setting aside a verdict. Pursuant to Penal Code Section 1203.45(g), the Board of Supervisors authorizes a fee of \$150 for the sealing of misdemeanor records."

Section 3. Section 4. Of Ordinance No. 720 is amended to read

"Pursuant to Family Code Section 9002, the Board of Supervisors authorizes the collection of a fee of \$344 for the reasonable cost incurred in connection with stepparent adoptions, including but not limited to costs incurred for the investigation required by Family Code Section 9001."

Section 4. Ordinance 720 is amended to add Section 5. to read as follows:

"Pursuant to Penal Code Section 1203.097(c)(5)(B) the Board of Supervisors authorizes a fee of up to \$250 each for approval and annual renewal of Batterers Diversion Programs."

Section 5. This Ordinance shall take effect thirty (30) days from the date of its adoption.



RECOMMENDED MOTION: That the Board of Supervisors:

1. Introduce and set for Public Hearing the proposed Ordinance 720.1 amending Ordinance 720, relating to the Fee Schedule for services rendered by the Probation Department as outlined in Attachment A
2. Upon the close of the Public Hearing, adopt Ordinance 720.1 amending Ordinance 720.

BACKGROUND: In accordance with Board of Supervisors Policy Number B-4, county departments may evaluate existing rates for services on an annual basis and make recommendations for changes. The California Penal Code provide for administrative fees to defray the cost of specified services rendered by the Probation Department. Proposed Amendment to County Ordinance 720 Relating to the Fee Schedule for Administrative Services Rendered by the Probation Department.

In an effort to ensure compliance with Board Policy B-4, the department has taken a proactive role in reviewing prior year records and documentation in order to bring the department fees current. Ordinance 720 was last amended on August 11, 1992, Agenda Item 11.10, to establish a fee schedule for the administrative fees such as change of plea, setting aside a verdict, sealing misdemeanor records and step-parent adoptions.

The Probation Department has completed an analysis of current costs and has recalculated the fees to reflect full cost recovery for all services provided based on FY2008/09 actual cost data. The appropriate updated billing rates are in accordance with the associated legal authority.

FINANCIAL DATA

These proposed rates have been reviewed by the Auditor-Controller's Office and approved as to form by County Counsel in accordance with the Board of Supervisors Policy B-4. If approved, the fee adjustments will result in an increase in revenue. The department anticipates a minimal increase in FY2009/10 and no budget adjustment will be required at this time.

ORDINANCE NO. 720.1

**AN ORDINANCE OF THE COUNTY OF
RIVERSIDE, AMENDING ORDINANCE
NO. 720 ESTABLISHING ADMINISTRATIVE
FEES FOR THE PROBATION
DEPARTMENT: INSTALLMENT
PAYMENT OF FINES, CHANGE OF
PLEA, SETTING ASIDE A VERDICT,
SEALING MISDEMEANOR RECORDS
AND STEPPARENT ADOPTIONS**

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 2. Of Ordinance No. 720 is amended to read as follows:

"Pursuant to Penal Code Section 1203.1b(h), when a judgment has been made that a defendant pays a fine, the fine may be paid by installment payments. The Board of Supervisors authorizes a fee of \$75.00 for the processing of installment accounts."

Section 2. Section 3. Of Ordinance No. 720 is amended to read as follows:

"Pursuant to Penal Code Section 1203.4(d), the Board of Supervisors authorizes a fee of \$150.00 to be charged to a person requesting a change of plea or setting aside a verdict. Pursuant to Penal Code Section 1203.45(g), the Board of Supervisors authorizes a fee of \$150 for the sealing of misdemeanor records."

Section 3. Section 4. Of Ordinance No. 720 is amended to read as follows:

"Pursuant to Family Code Section 9002, the Board of Supervisors authorizes the collection of a fee of \$344 for the reasonable cost incurred in connection with stepparent adoptions, including but not limited to costs incurred for the investigation required by Family Code Section 9001."

Section 4. Ordinance 720 is amended to add Section 5. to read as follows:

"Pursuant to Penal Code Section 1203.097 (c)(5)(B) the Board of Supervisors authorizes a fee of up to \$250 each for approval and annual renewal of Batterers Diversion Programs."

Section 5. This Ordinance shall take effect thirty (30) days from the date of its adoption.
