SUBJECT: Proposed Amendment to County Ordinance 591 Relating to the Approval of the Cost of Supervision and of Conducting Pre-Sentence Investigations and Preparing Pre-Sentence Reports.

RECOMMENDED MOTION: That the Board of Supervisors:

1. Introduce and Set for Public Hearing the proposed Ordinance 591.2 amending Ordinance 591.1, relating to the Fee Schedule for services rendered by Probation Department as outlined in Attachment A.
2. Upon the close of the Public Hearing, adopt Ordinance 591.2 amending Ordinance 591.1.

BACKGROUND: In accordance with Board of Supervisors Policy Number B-4, county departments may evaluate existing rates for services on an annual basis and make recommendations for changes. The California Penal Code 1203.1b provides that an individual convicted of an offense and granted probation may be ordered to pay the reasonable cost of supervision and of conducting the pre-sentence investigation and preparing the pre-sentence report.

In an effort to ensure compliance with Board Policy B-4, the department has taken a proactive role in reviewing prior year records and documentation in order to bring the department fees current. Ordinance 591.1 was last amended on March 13, 1990, Agenda Item 3.14, to establish a fee schedule for the costs associated with supervision, conducting investigations and preparing reports.

The Probation Department has completed an analysis of current costs and has recalculated the fees to reflect full cost recovery for all services provided based on FY2008/09 actual cost data. The appropriate updated billing rates are in accordance with the associated legal authority.

FINANCIAL DATA

These proposed rates have been reviewed by the Auditor-Controller's Office and approved as to form by County Counsel in accordance with the Board of Supervisors Policy B-4. If approved, the fee adjustments will result in an increase in revenue. The department anticipates a minimal increase in FY2009/10 and no budget adjustment will be required at this time. Attachment B shows comparison rates for the neighboring counties.
