**SUBJECT:** 2009 Riverside County Food Drive

**RECOMMENDED MOTION:** That the Board of Supervisors receive and file the attached "2009 H.E.L.P. Take A Bite Out Of Hunger" report and authorize distribution of \$34,446.14 to various Riverside County food banks and pantries.

**BACKGROUND:** Riverside County Board of Supervisors, the Economic Development Agency and Stater Bros. Supermarkets partnered to spearhead the second annual Riverside County Food Drive - *Take A Bite Out Of Hunger*. The food drive campaign ran from November 2009 through December 31, 2009. Over 10,500 pounds of food were collected in bins placed in forty-six Stater Bros. Supermarkets throughout Riverside County. F.I.N.D. Food Bank, serving the Coachella Valley, and Salvation Army, serving the western county, distributed the donated items to Riverside County residents in need. More than \$140,000 was raised through the assistance of the Board of Supervisors, Stater Bros. Supermarkets, on-line donations at [www.rcfooddrive.org](http://www.rcfooddrive.org) and the County fundraising campaign which allowed employees to buy wear-jeans-to-work stickers.
