BACKGROUND: (Continued)

Four work orders were issued pursuant to that contract for supplemental work; expanding existing septic system, modification of access to existing modular trailer, demolition and installation of Americans with Disabilities Act (ADA) parking spaces for code compliance, modification of existing handrails for safety, installation of temporary restrooms and showers for winter shelter, installation of bollards and bike racks at the Mental Health Safe Haven and Full Partnership Clinic in the total amount of \$113,849. The four projects have been inspected and found to comply with all contract requirements. This Board action will release the total balance of the contract retention funds of \$11,385 to MTM Construction.

All costs associated with this project will be fully funded by the State Mental Health Services Act, thus no Net County Cost will be incurred as a result of this action.
