## **BACKGROUND:**

The Board ordered the property owner to abate the violative conditions on the property and directed County Counsel to prepare the Findings of Fact, Conclusion and Order to Abate.

FINDINGS OF FACT, CONCLUSIONS AND ORDER TO ABATE NUISANCE

[R.C.O. Nos.348 and 725 R.C.C. Title 17.288 and 1]

The above-captioned matter came on regularly for hearing on March 16, 2010, before the Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real property described as 43271 E. Florida Avenue, Hemet, Riverside County, APN: 551-240-046 and referred to hereinafter as "THE PROPERTY."

Julie A. Jarvi, Deputy County Counsel, appeared along with Brian Black, Senior Code Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

Owners did not appear.

The Board of Supervisors received the Declaration of the Code Enforcement Officer, together with attached Exhibits, evidencing the excessive outside storage- metal shipping container on THE PROPERTY as a violation of Riverside County Ordinance No. 348, Section 18.50 (Riverside County Code Title 17.288), and as a public nuisance.

## SUMMARY OF EVIDENCE

- Documents of record in the Riverside County Recorder's Office identify the owners of 1. THE PROPERTY as Luigi Renna and Ae Suk Renna ("OWNERS").
- Documents of title at the time of the inspection indicated that other parties potentially hold 2. a legal interest in THE PROPERTY, to wit: Margaret Ann Ollerton, Mr. Bill Graber, Mary Beth Davidson, G.F. Partnership C/O Chandler, Potter & Associates ("INTERESTED PARTIES").
- THE PROPERTY has been inspected by Code Enforcement Officers on July 31, 2009, 3. October 16, 2009, December 11, 2009, January 11, 2010, February 17, 2010 and March 11, 2010.
- During each inspection, excess outside storage of materials metal shipping container was observed on THE PROPERTY.
- THE PROPERTY was determined to be in violation of Riverside County Ordinance No. 5. 348, Section 18.50 (Riverside County Code Title 17.288) by the Code Enforcement Officer.
- A Notice of Noncompliance was recorded on September 4, 2007 as Document Number 6. 2007-0563415 in the Office of the County Recorder, County of Riverside.
- On July 31, 2009, a Notice of Violation was posted on THE PROPERTY. On August 12, 7. 2009, a Notice of Violation was mailed to OWNERS and INTERESTED PARTIES by certified mail, return receipt requested.
- On February 11, 2010, a "Notice to Abate Nuisance" providing notice of the public 8. hearing before the Board of Supervisors on March 16, 2010, was mailed by certified mail, return receipt requested, to the OWNERS and INTERESTED PARTIES and was posted on THE PROPERTY on February 17, 2010.

## FINDINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on March 16, 2010, finds and concludes that:

WHEREAS, the excessive outside storage of materials - metal shipping container on the 1. real property located at 43271 E. Florida Avenue, Hemet, Riverside County, California, also identified as Assessor's Parcel Number 551-240-046 violates Riverside County Ordinance No. 348, Section 18.50 and constitutes a public nuisance.

2. WHEREAS, the OWNERS, occupants or any person having possession or control of the premises should abate the condition by removing and disposing of the excess outside storage of materialsmetal shipping container from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 348 within ninety (90) days of the posting or mailing of this order.

3. WHEREAS, THE OWNERS ARE HEREBY FUTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

## **ORDER TO ABATE NUISANCE**

IT IS THEREFORE ORDERED that the excess outside storage of materials-metal shipping container on THE PROPERTY be abated by the OWNERS or anyone having possession or control of THE PROPERTY, by removing the outside excess storage of materials – metal shipping container from the subject real property in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 348 within ninety (90) days of the posting or mailing of this order.

IT IS FURTHER ORDERED that if the materials are not removed in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 348, within ninety (90) days of the date of this Order, the excess outside storage of materials-metal shipping container shall be abated by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.

It is further ordered that reasonable abatement costs, after notice and opportunity for hearing, shall be imposed as a lien on the property, which may be collected as a special assessment against the property pursuant to Government Code section 25845 and Riverside County Ordinance nos. 457, 348, 541, and 725. Under Riverside County Ordinance 725, "abatement costs" means "any costs or expenses reasonably related to the abatement of conditions which violate County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation, collection and administrative costs, attorneys fees, and the

costs associated with the removal or correction of the violation." Reasonable abatement costs accrued by the Department will be recoverable from the property owner(s) even if the property is brought into compliance within ninety (90) days of the date of this Order to Abate Nuisance.




