- 3. If the owner of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, shall abate the excess outside storage by removing the same from the real property.
- The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials on the real property is declared to be in violation of Riverside County Ordinance No. 348, and a public nuisance, and further, to prepare and Order to Abate for approval by the Board.

JUSTIFICATION:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on July 31, 2008.
- 2. The inspection revealed the excess outside storage of materials or junkyard on the subject property in violation of Riverside County Ordinance No. 348. The items included but were not limited to: scrap wood, firewood, household items, furniture, building materials, fencing, construction materials and appliances. The amount of outside storage was determined to be in excess of four hundred (400) square feet.
- 3. Subsequent re-inspections of the above-described real property on August 6, 2008, February 24, 2009, June 1, 2009, August 3, 2009, October 19, 2009, November 12, 2009, November 30, 2009 and March 2, 2010, revealed that the property continued to be in violation of Riverside County Ordinance No. 348.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the Administrative Abatement Proceedings for the removal of excess outside storage.

- I, Brett Pollard, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and based thereon allege that on July 31, 2008, Senior Code Enforcement Officer Martinez and Code Enforcement Officer Ross conducted an initial inspection of the real property described as 39255 Sage Road, Hemet, Riverside County, California and further described as APN 571-120-008 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is currently owned by Jessica Louise See (hereinafter referred as "OWNER"). THE PROPERTY was formerly owned by Julee and Johnny Wineland (hereinafter referred as "FORMER OWNERS"). Certified copies of the County Equalized Assessment Roll for the year 2009-2010 and County Geographic Information System ("GIS") report is attached hereto as Exhibit "B." THE PROPERTY is located within the R-R (Rural Residential) zone classification. This zone classification allows outside storage on an improved parcel with the amount of storage to be two hundred (200) square feet for properties that are a minimum of one-half acre in size. THE PROPERTY is unimproved and approximately 2.5 acres.
- 4. Based upon the copy of a Lot Book Report issued by RZ Title Service on August 5, 2009, it is determined that other parties potentially hold a legal interest in THE PROPERTY, to wit: Mary

Woolsey and Gregory Rizio, Esq. (hereinafter referred to as "INTERESTED PARTIES"). A true and correct copy of the Lot Book Report is attached hereto and incorporated herein as Exhibit "C."

- 5. I am informed and believe and based thereon allege that on July 31, 2008, Senior Code Enforcement Officer Martinez and Code Enforcement Officer Ross drove to THE PROPERTY to conduct an inspection. They entered THE PROPERTY on a road that was open and accessible and observed excess outside storage on THE PROPERTY. The excess outside storage consisted of but was not limited to: scrap wood, firewood, household items, furniture, building materials, fencing, construction material and appliances. As a result of the outside storage, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 348, as codified in Riverside County Code ("RCC") Chapter 17.16.
 - 6. On July 31, 2008, a Notice of Violation was posted on THE PROPERTY.
- 7. I am informed and believe and based thereon allege that on August 6, 2008, Supervising Code Enforcement Officer Slocum, Senior Code Enforcement Officer Martinez, Code Enforcement Officers Ross, Ryder and Heagstedt went to THE PROPERTY to conduct a follow up inspection. THE PROPERTY was open and accessible and the officers observed that the parcel remained unchanged.
- 8. On August 6, 2008, FORMER OWNER, Julee Wineland was cited with a Notice to Appear for the conditions of THE PROPERTY. On August 8, 2008, the Notice to Appear was mailed to FORMER OWNER by certified mail, return receipt requested. On October 23, 2008, a Corrected Notice to Appear was mailed to FORMER OWNER by certified mail, return receipt requested.
- 9. I am informed and believe and based thereon allege that on February 24, 2009 and June 1, 2009, Officer Ryder returned to THE PROPERTY which was open and accessible for follow-up inspections. Officer Ryder observed no difference in the conditions of the site.
- 10. On June 1, 2009, a Notice of Violation was mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested.
- 11. On August 3, 2009, October 19, 2009 and November 12, 2009 and November 30, 2009, I went to THE PROPERTY to conduct follow up inspections. During my August 3, 2009 inspection, I made contact with FORMER OWNER, Julee Wineland who stated that the property is now in her

daughter's name. During each inspection, I observed that THE PROPERTY remained in violation of RCO 348 (RCC Chapter 17.16).

- A site plan and photographs of the condition of THE PROPERTY are attached hereto as 12. Exhibit "D" and are incorporated herein by reference.
- True and correct copies of each Notice issued in this matter and other documentation are 13. attached hereto as Exhibit "E" and incorporated herein by reference.
- 14. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 15. I am informed and believe and based upon said information and belief alleges that the OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 16. A Notice of Non-Compliance was recorded in the Office of the County Recorder, County of Riverside, State of California, on March 9, 2009 as Instrument Number 2009-0111185, a true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F".
- On March 2, 2010, I conducted another inspection of THE PROPERTY which revealed 17. that THE PROPERTY remained in violation of RCO 348 (RCC Chapter 17.16).
- 18. On March 1, 2010, the second notice – "Notice to Abate Public Nuisance" providing notification of the Board hearing scheduled for April 6, 2010, as required by Riverside County Ordinance No. 725, was mailed to the OWNER and INTERESTED PARTIES by certified mail, return receipt requested and on March 2, 2010, was posted on THE PROPERTY. True and correct copies of the notice, returned receipt cards, together with the proof of service, and the affidavit of posting of notices are attached hereto as Exhibit "G" and are incorporated herein by reference.
- The removal of all outside storage of materials currently on THE PROPERTY is required 19. to bring THE PROPERTY into compliance with Riverside County Ordinance Nos. 348 and the Health and Safety Code.

- 20. Accordingly, the following findings and conclusions are recommended:
 - (a) the outside storage of materials on THE PROPERTY be deemed and declared a public nuisance;
 - (b) the OWNER or whoever has possession or control of THE PROPERTY be required to remove all storage of materials on THE PROPERTY in accordance with the provisions of County Ordinance No. 348.
 - (c) that if the materials are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 348, within ninety (90) days of the date of this Order, the outside storage of materials shall be abated by representatives of the Riverside County Department of Building and Safety, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order when necessary under applicable law.
 - (d) that reasonable costs of abatement, after notice and opportunity for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE PROPERTY pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 348 and 725.








