(2)James Gonzales, the owner of the subject real property, be directed to abate the substandard structures on the property by rehabilitating, removing and/or demolishing the same from the real property, including the removal and disposal of all structural debris and materials, within ninety (90) days.

- (3) The owner be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- (4) The accumulation of rubbish on the real property located at 18050 Rice Road, Desert Center, be declared a public nuisance and a violation of Riverside County Ordinance No. 541 which does not permit the accumulation of rubbish on the property.
- (5) James Gonzales, the owner of the subject property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days.
- (6) If the owner of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owners, receipt of a Court Order authorizing entry onto the real property, or other authorization as provided by law, shall abate the substandard structure and the accumulation of rubbish by removing and disposing of the same from the real property
- (7) The reasonable cost of the abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Ordinance No. 725.
- (8) County Counsel be directed to prepare the necessary Findings of Fact and Conclusions of Law that the substandard structures on the real property and the accumulation of rubbish are declared to be in violation of Riverside County Ordinance Nos. 457 and 541 and constitute a public nuisance. Further, County Counsel shall prepare an Order to Abate for approval by the Board.

# **JUSTIFICATION:**

- 1. An initial inspection was made of the subject real property by the Code Enforcement Officer on January 14, 2010.
- The inspection revealed three substandard structures (dwelling, garage & agricultural building) on the subject real property in violation of Riverside County Ordinance No. 457. The substandard conditions of the structures included, but were not limited to the following: members of walls, partitions or other vertical supports that split, lean, list or buckle due to defective material or deterioration; members of ceilings, roofs, ceiling and roof supports or other horizontal members which sag, split or buckle due to defective material or deterioration; faulty weather protection; general dilapidation or improper maintenance; public and attractive nuisance.

The inspection also revealed the accumulation of rubbish (approximately 6,005 square feet) on the subject property in violation of Riverside County Ordinance No. 541he accumulation of rubbish consisted of, but was not limited to the following materials: over 100 tires, wood, household trash, metal poles, green waste, broken furniture, broken glass, broken windows, metal siding, metal drums, small appliances, a truck shell, clothes, swamp coolers, miscellaneous car parts, televisions, patio furniture and other miscellaneous items.

3. Staff and the Code Enforcement Department have complied with the requirements set forth in the appropriate laws of this jurisdiction pertaining to the Administrative Abatement Proceedings for substandard structure and accumulation of rubbish.

I, Regina Keyes, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true and if called as a witness, I could and would competently testify under oath:

- I am currently employed by the Riverside County Code Enforcement Department as a Senior Code Enforcement Officer. My current official duties as a Senior Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On January 14, 2010, Senior Code Enforcement Officer Gianos, Code Enforcement Officer Torres, Code Enforcement Aide Miller and I conducted an initial inspection of the real property known as 18050 Rice Road, Desert Center, within the unincorporated area of Riverside County, California, which is further described as Assessor's Parcel Number 810-020-001 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the approximate location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- 3. A review of County records and documents indicate that THE PROPERTY was owned by James Gonzales (hereinafter referred to as "OWNER") at the time of the inspection referenced in paragraph number 2 above. Certified copies of the County Equalized Assessment Roll for the year 2009-2010 and County Geographic Information System ("GIS") report are attached hereto as Exhibit "B" and incorporated herein by reference.
- 4. Based on the Lot Book Report from RZ Title Service dated January 26, 2010, it is determined that additional parties potentially hold a legal interest in THE PROPERTY, to wit: Susan

Feller, Esq., Internal Revenue Service, State of California Franchise Tax Board, Richard B. Beck, Esq., Canyon Lake Homeowners Association and City of Riverside (hereinafter collectively referred to as "INTERESTED PARTIES"). A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and incorporated herein by this reference.

- 5. On January 14, 2010, Senior Code Enforcement Officer Gianos, Code Enforcement Officer Torres, Code Enforcement Aide Miller and I conducted an initial inspection of THE PROPERTY on which I observed three structures (dwelling, garage & agricultural building) in a state of general dilapidation. THE PROPERTY was open and accessible with no signs posted to restrict access. I observed the following conditions which cause the structures to be substandard and THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance 457, as codified in Riverside County Code Title 15:
  - 1) Members of walls, partitions or other vertical supports that split, lean, list or buckle due to defective materials or deterioration;
  - 2) Members of ceiling, roofs, ceiling and roof supports or other horizontal members which sag, split, or buckle due to defective material or deterioration;
  - 3) Faulty weather protection;
  - 4) General dilapidation or improper maintenance;
  - 5) Public and attractive nuisance.
- 6. During the initial inspection on January 14, 2010, I also observed large amounts of accumulated rubbish on THE PROPERTY including, but not limited to: over 100 tires, wood, household trash, metal poles, green waste, broken furniture, broken glass, broken windows, metal siding, metal drums, small appliances, a truck shell, clothes, swamp cooler, miscellaneous car parts, televisions, patio furniture and other miscellaneous items. The total area of the accumulated rubbish was approximately six thousand five (6,005) square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of Riverside County Ordinance No. 541, as codified in Riverside County Code Chapter 8.
- 7. A site plan and photographs reflecting the substandard condition of the structures and the accumulated rubbish on THE PROPERTY are attached hereto as Exhibit "D" and incorporated herein by reference.
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.


- 9. On January 14, 2010, I posted Notices of Defects, Notices of Violation (RCC 15.16.020 Substandard Structures and RCC 8.120 Accumulation of Rubbish), "Danger Do Not Enter" signs, and a "Do Not Dump" sign on THE PROPERTY.
- 10. On January 28, 2010, a Notice of Noncompliance for the substandard structures and accumulated rubbish was recorded against THE PROPERTY as instrument number 2010-0039006. A true and correct copy of the recorded Notice of Noncompliance is attached hereto and incorporated by reference as Exhibit "F".
- 11. On February 2, 2010, Notices of Violation (RCC 15.16.020 Substandard Structures and RCC 8.120 Accumulation of Rubbish) were mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested.
- 12. I am informed and believe, and based upon said information and belief, allege that OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 13. Based upon my experience, knowledge and visual observations, it is my determination that the substandard structures on THE PROPERTY creates an extreme health, safety, fire and structural hazard to the neighbors and general public and constitutes a public nuisance in violation of the provisions set forth in Riverside County Ordinance Nos. 457 and 541.
- 14. On March 11, 2010, the "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors hearing scheduled for April 6, 2010, as required by Riverside County Ordinance No. 725, was mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested and on March 15, 2010 was posted on THE PROPERTY. True and correct copies of the notice, return receipt cards, together with the proof of service and the affidavit of posting of notices are attached hereto as Exhibit "G" and incorporated herein by reference.
- 15. A follow-up inspection on March 15, 2010 revealed that THE PROPERTY remains in violation.
- 16. Significant rehabilitation, removal and/or demolition of the substandard structures and removal and disposal of all structural materials, rubbish and debris are required to abate the public

nuisance and bring THE PROPERTY into compliance with Riverside County Ordinance Number 457 (RCC Title 15), the Health and Safety, Uniform Housing, Administrative and Abatement of Dangerous Buildings Codes. In addition, the removal and disposal of all rubbish on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 541.

- 17. Accordingly, the following findings and conclusions are recommended:
- (a) The structures be condemned as substandard buildings, public and attractive nuisance;
- (b) The OWNER, or whoever has possession or control of THE PROPERTY, be required to rehabilitate or demolish said structures, including the removal and disposal of all structural debris and materials, on THE PROPERTY in strict accordance with the provisions of Riverside County Ordinance No. 457 (RCC Title 15);
- (c) The OWNER, or whoever has possession or control of THE PROPERTY, be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the Riverside County Health Department, Division of Special Services; and, prior to the abatement ordered in subsection (b) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines by South Coast Air Quality Management District ("SCAQMD") pursuant to SCAQMD Rule NO. 1403;
- (d) If the substandard structures are not razed, removed and disposed of, or reconstructed in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 457 (RCC Title 15), within ninety (90) days after the posting and mailing of the Board's Order and Findings, the substandard structures and contents therein shall be abated by representatives of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon receipt of an owner's consent or a Court Order, where necessary under applicable law, authorizing entry onto THE PROPERTY; and


