- (3) If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, shall abate the accumulation of rubbish by removing and disposing of the same from the real property.
- (4) The reasonable cost of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- (5) County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

# JUSTIFICATION:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on September 22, 2009.
- 2. The inspection revealed an accumulation of rubbish on the subject property in violation of Riverside County Ordinance No. 541. The items included but were not limited to: green woody waste, tires, appliances, furniture, mattresses, household items, scrap wood, household trash and other miscellaneous debris.
- 3. A subsequent follow up inspections of the above-described real property on December 2, 2009 and February 26, 2010, revealed that the property continued to be in violation of Riverside County Ordinance No. 541.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage and accumulated rubbish.

I, Regina Keyes, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:

- I am currently employed by the Riverside County Code Enforcement Department as a Senior Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- On September 22, 2009, Code Enforcement Technician Miller and I conducted an initial 2. inspection of the real property described as 64125 Mobile Road, Desert Hot Springs, Riverside County, California and further described as Assessor's Parcel Number 663-081-015 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- A review of County records and documents disclosed that THE PROPERTY was owned by M.J. Moore (hereinafter referred to as the "OWNER"). Certified copies of the County Equalized Assessment Roll for the year 2009-2010 and County Geographic Information System ("GIS") report is attached hereto as Exhibit "B" and incorporated herein by reference.
- Based on the Lot Book Report from RZ Title Service on September 11, 2009, it is 4. determined that an additional party may potentially hold a legal interest in THE PROPERTY, to wit: Mission Springs Water District (hereinafter referred to as "INTERESTED PARTY"). A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and incorporated herein by reference.
- On September 22, 2009, Code Enforcement Technician Miller and I conducted an initial 5. inspection of THE PROPERTY. The parcel was open and accessible and I observed a large accumulation of rubbish throughout THE PROPERTY consisting of but not limited to: green woody waste, tires,


appliances, furniture, mattresses, household items, scrap wood, household trash and other miscellaneous debris. Using the Riverside County Land Information System and the recorded lot size of the parcel, I calculated the amount of rubbish as ten thousand (10,000) square feet. I posted a Notice of Violation on THE PROPERTY.

- 6. As a result of the accumulation of rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance No. 541, as codified in Riverside County Code Title 8.120.
- 7. A site plan and photographs of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 9. On September 25, 2009, a Notice of Violation was mailed to OWNER and INTERESTED PARTY by certified mail, return receipt requested.
- 10. On December 2, 2009, I conducted a follow-up inspection of THE PROPERTY. From the road right of way, I observed the parcel was unchanged and remained in violation of Riverside County Ordinance No. 541.
- 11. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 12. A Notice of Noncompliance regarding the accumulation of rubbish was recorded in the Office of the Assessor, County Clerk & Recorder, County of Riverside, State of California, on April 22, 2008, as Instrument Number 2008-0199609. A true and correct copy of the notice is attached hereto and incorporated herein by reference as Exhibit "F".
- 13. On February 24, 2010 the second notice, "Notice to Abate Public Nuisance" providing notification of the Board of Supervisors' hearing scheduled for April 6, 2010, was mailed to OWNER and INTERESTED PARTY by certified mail, return receipt requested and on February 26, 2010 was posted on THE PROPERTY. True and correct copies of the notice and supporting documentation are attached hereto as Exhibit "G" and incorporated herein by reference.


