SUBJECT: Notices of Completion for the Construction of Multi-Level Gas Detection Probes at the Badlands and Lamb Canyon Sanitary Landfills

RECOMMENDED MOTION: That the Board of Supervisors:

1. Accept the Construction of Multi-Level Gas Detection Probes at the Badlands and Lamb Canyon Sanitary Landfills by Cascade Drilling, LP and authorize the Chairman to execute the attached Notices of Completion for each location; and
2. Direct the County Clerk to file the executed Notices of Completion for each location.

BACKGROUND: On November 3, 2009, the Board awarded Cascade Drilling, LP the contract to construct multi-level gas detection probes at the Badlands and Lamb Canyon Sanitary Landfills. On December 31, 2009, construction of the multi-level probes was satisfactorily completed. The original contract amount was \$259,718.00 and the final cost of the project is \$266,077.00, 2.45% more than the original contract amount. The additional \$6,359 spent on the project resulted from drilling the bore-holes deeper than expected due to field conditions.
