**SUBJECT:** Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc.

**RECOMMENDED MOTION:**

- 1) Ratify the Amendment to the Agreement with Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc., effective January 1, 2010;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

**BACKGROUND:** Effective February 1, 2007, RCRMC was awarded a grant from the Riverside County Children and Families Commission, also known as First 5 Riverside, to provide dental screening and education services to children less than 5 years of age. The grant was renewed and funding increased effective July 1, 2009. As a result of this funding increase, additional dental services can be provided to children requiring care. Elias, Elliott, Lampasi, Fehn, Harris & Nguyen, a Dental Practice, Inc. has agreed to provide additional dental care and oral surgery services.

The Amendment has been approved as to form by County Counsel.

- 14 1. Delete section 3.2 in its entirety and replace as follows:

15 Maximum payments to CONTRACTOR shall not exceed one hundred  
16 thousand (\$100,000) dollars per year. Payments to CONTRACTOR shall  
17 be made on a monthly basis during the Term of this Agreement.

18 All other terms and conditions of this Agreement are to remain unchanged.
