BACKGROUND: On January 7, 1997, the Board of Supervisors formed the Citizens Oversight Committee for the Synagro Composting Co. (formerly Recyc In Regional Composting Facility) in order to provide a forum for area residents to address concerns and answer questions the community may have. Pursuant to the Settlement Agreement dated November 2003 between Synagro Composting Co. and the County of Riverside, CUP 2999 expired on December 31, 2008. Final cleanup was also required as of that date and no composting activities are presently active on the site. As such, the Oversight Committee is no longer necessary for its stated purpose and should be dissolved pursuant to Board Policy A-21.
