## **BACKGROUND:**

On June 2, 2009 (#3.22), the Board of Supervisors approved the Master Service Agreement #6160014874, with SCG authorizing CAP Riverside to install weatherization measures, including appliance repair and replacement, in homes of eligible low-income residents of Riverside County and conduct energy education workshops.

Release Order #5660017483 establishes funding for program year 2010 for the term January 1, 2010 through January 24, 2011.

Therefore, the Executive Director of CAP Riverside requests that the Board approve Release Order #5660017483 not to exceed \$86,100 covering the term January 1, 2010 through January 24, 2011.

**FINANCIAL IMPACT:** No County General Funds will be required. \$21,525 will be expended in FY 2009/2010. The balance of \$64,575 will be included in FY 10/11 through the normal budgeting process.
