SUBJECT: Chiriaco Summit Airport Apron Rehabilitation Project – Notice of Completion

BACKGROUND: The purpose of the project was the rehabilitation of the Apron Taxiway area adjacent to runway 6-24 located at the Chiriaco Summit Airport, and is consistent with the airport's development plan. Specific improvements included apron re-construction, segmented circle placement and airfield markings, in keeping with current State Division of Aeronautics guidelines for General Aviation facilities. The project was completed on March 29, 2010, and the airport has been returned to its full operational capacity.
