- (3) If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, shall abate the accumulation of rubbish by removing and disposing of the same from the real property.
- (4) The reasonable cost of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- (5) County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

- 1. An initial inspection was made of the subject property by the Code Enforcement Officer on August 19, 2008.
- 2. The inspection revealed an accumulation of rubbish on the subject property in violation of Riverside County Ordinance No. 541. The items included but were not limited to: tires, barrels, paint buckets and miscellaneous debris.
- 3. Subsequent follow up inspections of the above-described real property on November 3, 2008, August 19, 2009, September 3, 2009, October 29, 2009, November 4, 2009 and March 9, 2010, revealed that the property continued to be in violation of Riverside County Ordinance No. 541.
- 4. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage and accumulated rubbish.

DECLARATION OF CODE ENFORCEMENT OFFICER ANGELA FRAZIER

[R.C.O. No. 541 (RCC Title 8.120)]

- I, Angela Frazier, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereto under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and based thereon allege that on August 19, 2008, Code Enforcement Officer Pollard conducted an initial inspection of the real property described as 22761 Alessandro Avenue, San Jacinto, Riverside County, California and further described as Assessor's Parcel Number 434-260-016 (hereinafter referred to as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map indicating the location of THE PROPERTY is attached hereto as Exhibit "A" and incorporated herein by reference.
- 3. A review of County records and documents disclosed that THE PROPERTY was owned by HSBC Bank USA (hereinafter referred to as the "OWNER"). Certified copies of the County Equalized Assessment Roll for the year 2009-2010 and County Geographic Information System ("GIS") report is attached hereto as Exhibit "B" and incorporated herein by reference.
- 4. Based on the Lot Book Report from RZ Title Service on December 8, 2009, it is determined that no additional parties may potentially hold a legal interest in THE PROPERTY. A true and correct copy of the Lot Book Report is attached hereto as Exhibit "C" and incorporated herein by reference.

Officer Declaration

- 5. I am informed and believe and based thereon allege that on August 19, 2008, Code Enforcement Officer Pollard conducted an initial inspection of THE PROPERTY. THE PROPERTY was open and accessible and the officer observed an accumulation of rubbish throughout THE PROPERTY consisting of, but not limited to: tires, barrels, paint buckets and miscellaneous debris. Officer Pollard subsequently posted a Notice of Violation on THE PROPERTY on September 9, 2008.
- 6. As a result of the accumulation of rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance No. 541, as codified in Riverside County Code Title 8.120.
- 7. A site plan and photographs of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto as Exhibit "E" and incorporated herein by reference.
- 9. On September 2, 2008, March 25, 2009, April 30, 2009 and August 20, 2009, a Notice of Violation was mailed to OWNER by certified mail with return receipt requested.
- 10. I am informed and believe and based thereon allege that on November 3, 2008, Officer Pollard conducted a follow-up inspection of THE PROPERTY. From the road right of way he observed the parcel was unchanged and remained in violation of Riverside County Ordinance No. 541.
- 11. On August 19, 2009, September 3, 2009, October 29, 2009 and November 4, 2009, I conducted follow up inspections of THE PROPERTY. During each inspection, from the road right of way, I observed the accumulated rubbish continued to remain on THE PROPERTY in violation of the provisions set forth in Riverside County Ordinance No. 541.
- 12. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 13. A Notice of Noncompliance regarding the accumulation of rubbish was recorded in the Office of the Assessor, County Clerk & Recorder, County of Riverside, State of California, on May 19, 2009, as Instrument Number 2009-0252404. A true and correct copy of the notice is attached hereto and incorporated herein by reference as Exhibit "F".

- 14. On March 8, 2010 the second notice, "Notice to Abate Public Nuisance" providing notification of the Board of Supervisors' hearing scheduled for May 4, 2010, was mailed to OWNER by certified mail, return receipt requested and on March 9, 2010 was posted on THE PROPERTY. True and correct copies of the notice and supporting documentation are attached hereto as Exhibit "G" and incorporated herein by reference.
- 15. A follow-up inspection on March 9, 2010 revealed that THE PROPERTY remains in violation.
- 16. Removal of the accumulation of rubbish on THE PROPERTY is required to bring THE PROPERTY into compliance with Riverside County Ordinance No. 541 (RCC Chapter 8.120) and the Health and Safety Code. Under RCO No. 541, no amount of rubbish is allowed to accumulate on THE PROPERTY.
- 17. The Board of Supervisors is requested to issue an Order to Abate the Nuisance described herein. Accordingly, the following findings and conclusions are recommended:
- (a) the accumulation of rubbish on THE PROPERTY to be deemed and declared a public nuisance;
- (b) the OWNER and person(s) in possession of THE PROPERTY be required to remove all accumulated rubbish within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, in accordance with all Riverside County Ordinances, including but not limited to the provisions of County Ordinance No. 541;
- (c) in the event the rubbish is not removed and disposed of according to the above referenced ninety (90) day time period in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinance No. 541 (RCC Chapter 8.120), the rubbish shall be abated by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department; and




