- 3) Authorize the Chairperson to sign said three (3) original "Acceptance Award" Letter and four (4) original copies of the Sixth Amendment with ALAC; and
- 4) Authorize the Purchasing Agent to sign future contract amendments limited to the shifting of funds between budgetary line items as needed to facilitate the delivery of program services. Any amendments which would alter the original approved total grant award or change any given fiscal years' revenues or modify the lifetime of the grant will be brought to the Board of Supervisors for approval.

#### **BACKGROUND:**

On November 2, 1999, Item 3.22, the Board authorized the Community Health Agency Department of Public Health Disease Control Branch (Department) to accept the first year subventions funding from the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) to be issued to ALAC in a single source subcontract for existing projects.

The subcontract with ALAC, TB education and prevention, was approved by the Board of Supervisors on January 11, 2000. Subsequently, two more agreements were approved, one for Refugee Health Activities and one for prevention activities funded by calendar year. The original contract expired after seven amendments. A new contract #04-002 with ALAC for the Local Assistance Funding was approved by the Board on October 7, 2003, agenda item 3.15, for Fiscal Year 03/04. The First Amendment to the agreement was approved by the Board on October 19, 2004, agenda item 3.13, for Fiscal Year 04/05. The Second Amendment to the agreement was approved by the Board on October 4, 2005, Agenda item 3.8. The Third Amendment to the agreement was approved by the Board on August 29, 2006, agenda item 3.25 for Fiscal Year 06/07. The Forth Amendment to the agreement was approved by the Board on February 26, 2008, agenda item 3.22, for Fiscal Year 07/08. The Fifth Amendment to the agreement was approved by the Board on December 23, 2008, item 3.9. This Sixth Amendment to the agreement is for the performance period of July 1, 2009 through June 30, 2010, in the amount of \$154,046.

This Award Letter is for the amount of \$161,499. Of this amount \$154,046 is state funding for ALAC to support tuberculosis prevention and control activities, and \$7,453 is for Riverside County Administrative costs.

Fiscal Year 2009/2010 budget includes the amount of \$161,499 as been included; no budget adjustment is required at this time.

That certain Agreement between the COUNTY OF RIVERSIDE ("COUNTY") and American Lung Association of California ("CONTRACTOR"), approved on October 07, 2003 Item 3.15, amended for the first time on October 19, 2004, Item 3.13, amended for the second time on October 4, 2005, Item 3.8, amended for the third time on August 29, 2006, Item 3.25, amended for the fourth time on February 26, 2008, agenda item 3.22, amended for the fifth time on December 23, 2008, item 3.9, is hereby amended for the sixth time as follows, effective July 1, 2009:

- To amend all references to the period of performance from July 1, 2008 through June 30, 2009 to July 1, 2009 through June 30, 2010.
