

RESOLUTION NO. 2010-123

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE **ESTABLISHING MILEAGE OF MAINTAINED COUNTY ROADS PURSUANT TO SECTION 2121 OF STREET AND HIGHWAYS CODE**

WHEREAS, Section 2121 of the Street and Highways Code provides that each County annually shall submit to the California State Department of Transportation any additions to; or exclusions from; its mileage of each route added or excluded; and,

WHEREAS, the California State Department of Transportation certified in May 2009 to the California State Controller that the total mileage of County maintained roads in Riverside County was 2,523.24 miles; and,

WHEREAS, the County now finds that the total mileage of County maintained roads is 2.556.26:

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on May 18, 2010 that the mileage of County maintained roads be as graphically shown on a set of maps entitled "County Maintained Road System", Riverside County, April 1, 2010, marked Exhibit "A", and as detailed by termini and length of each route in a tabulation entitled "Tabulation of County Maintained Road System", April 1, 2010, marked Exhibit "B", both of which are on file in the office of the Clerk of the Board of Supervisors and both of which are, by this reference, incorporated in and made a part hereof with the same effect as if they were physically attached thereto; and,

BE IT FURTHER RESOLVED that a true copy of Resolution No. 2010-123 duly certified by the Clerk of the Board, accompanied by true copies of said Exhibits "A" and "B", be transmitted to the California State Department of Transportation by the Transportation Department of Riverside County.
